## **UPDATES**

Travel Guide – Out stock of the 2010 guide will soon be depleted. We need more photos for the guide as well as the website and the EDC Portal.

Guide Cover - Experience has shown that having people on the cover does not result in the guide being taken...Animals are much more popular. A set of alpaca twins (very unique and rare) have been born at Philwold. 2011 State Matching Funds – We have already received and submitted our application for the maximum amount. We will also be applying for state grants. We will be scheduling spring meetings on our programs and co-op marketing.

EDC/Virtual Portal - The portal will be taking important aspects from each of the EDC organizations.

Bus Wrap – A sample was passed around. A motion to accept the proposed bus wrap was made by Duttweiler and seconded by Tinari. Approved.

**Sullivan County Cultural Map** – The map/guide was available at the Harvest Festival's Arts last month. Everyone was encouraged to take a supply.

**Board Retreat** – Dutweiller thought the retreat was an overall success.

## **NEW BUSINESS**

Caltabellotta presented an advertising opportunity in the Sullivan County Community Chorus' program.

Tinari presented two marketing ideas: 1) an event "stand" to be placed on the county's restaurant tables 2) an app (picture) to go to our website
