WHEREAS, the New York State economy has reportedly entered into a recession, a position that is supported by a global financial crisis, the epicenter of which is New York City that generally affects the Hudson Valley regional economy, and

WHEREAS, the County's unemployment rate, as of September 2008 was 6.6 percent, one percent higher than New York State, with the fifth highest unemployment rate in New York State, and

WHEREAS, at such a time when there will be such fiscal pressures upon Sullivan County, indeed upon the general citizenry of the County, it is unacceptable for the property taxpayers of Sullivan County to pay property taxes to fund employment positions for residents of other New York State Counties or the State of Pennsylvania, and

WHEREAS, all employment positions that require a new hire in the county government must be reserved for bona fide residents of Sullivan County, whose primary residence is within the geographic borders of Sullivan County, and

WHEREAS, at the very least, if a non-resident of Sullivan County is offered and accepts an employment position with the County of Sullivan, then they should relocate and become a bona fide resident within six (6) months of their employment, and

WHEREAS, it is in the best interests of Sullivan County to formalize and clarify this important public policy.

- **NOW, THEREFORE, BE IT RESOLVED** by the Sullivan County Legislature that the Public Policy of the County of Sullivan shall include the following regarding employment with the County:
- (1) <u>All</u> future new employees shall, to the extent permitted by law, be bona fide residents of Sullivan County, and shall legally attest that their primary residence is within the geographic boundaries of Sullivan County.
- (2) <u>All</u> appointing authorities (County Manager, County Attorney, County Auditor, Division Commissioners, and Department Heads) shall, to the extent permitted by law, first be required to request a residents only civil service certification list from the Office of Personnel and Civil Service Administration for the appointment to any employment position within their jurisdiction that is subject to the civil service appointment process.
- (3) All appointing authorities shall, to the extent permitted by law, be required to appoint bona fide residents of Sullivan County, who have legally attested that their

primary residence is within the geographic boundaries of Sullivan County to any new hire provisional, temporary, or permanent employment position within their jurisdiction.

- (4) The only exceptions to 2, 3, and 4 above, would be a certification by the appointing authority and personnel officer to the County Manager that there are no qualified bona fide residents of Sullivan County that may be appointed to the position. However, such appointee shall be required to become a bona fide resident of Sullivan County within six (6) months of appointment, or upon the completion of their probationary period.
- (5) <u>All</u> management and confidential employees that are appointed to serve at the pleasure of the County Legislature, County Attorney, or County Manager, shall, to the extent permitted by law, be required to maintain a bona fide residence within the geographic boundaries of Sullivan County, as their legal primary residence, in order to enjoy such continued employment.

RESOLUTION NO. INTRODUCED BY MANAGEMENT AND BUDGET TO URGE THE NEW YORK STATE LEGISLATURE TO ADOPT LEGISLATION TO MAKE SCHOOL DISTRICTS WHOLE, SUBJECT TO REIMBURSEMENT BY LOCAL TAX DISTRICTS THAT ENFORCE DELINQUENT SCHOOL DISTRICT TAXES)

WHEREAS, New York State currently requires local governments that enforce delinquent school district taxes to pay all school districts that accept students from their locale for their uncollected taxes, no later than April 1st of each and every year, and

WHEREAS, unlike most towns, school districts never collect enough taxes to cover their own warrants, so that after November 30th, all unpaid school taxes become the sole obligation of the local tax district that enforces said collection to pay, and

WHEREAS, this requirement is known as "making schools whole" for uncollected taxes, and

WHEREAS, the vast majority of tax districts in New York State required to make schools whole are county governments, including Sullivan County, and

WHEREAS, Sullivan County is required, therefore, to make its schools whole by April 1st of every year even though the county has not collected all outstanding school taxes owed at that time, meaning that the Sullivan County must front its own money to the schools, and hope that during the remainder of the year it will collect the rest of the unpaid taxes from delinquent property owners, and

WHEREAS in 2006 and 2007, Sullivan County paid \$15 Million each year to make schools whole, and in 2008 the number rose to \$16 Million, and

WHEREAS, an analysis indicates that this monetary obligation has increased significantly over the years, and that the 2007 payment of \$15 Million represents an increase of almost 43 percent from 2004 through 2007, and

WHEREAS, the cash flow that is lost to county governments often necessitates that counties must borrow money to pay their own operating costs, thereby making it very difficult for many counties, including Sullivan County, to afford to pay for operating expenses without incurring additional debt, which costs taxpayers money for interest and costs of borrowing, and

WHEREAS, this burden on county government negatively impacts our general fund balance, our cash flow, our bond rating, our ability to save money and to lower the costs of providing services, and

WHEREAS, it would be more appropriate and in the best interests of the taxpayers of Sullivan County and New York State for the State government to make schools whole and to alleviate this extreme burden from the backs of county taxpayers, and

WHEREAS, this proposal to shift the initial outlay from the counties to the State is uniquely fair to State Government in that local tax districts would retain the obligation to collect the delinquent school taxes and would, therefore, reimburse the State as it collected the delinquent school taxes on the local level, and

WHEREAS, this proposal would save local taxpayers money and would enable local tax districts to provide more and better services, more efficiently and less expensively,

NOW, THEREFORE BE IT RESOLVED that the Sullivan County Legislature hereby urges the New York State Legislature to adopt legislation to make school districts whole subject to reimbursement by local tax districts that enforce delinquent school district taxes, and

NOW, THEREFORE, BE IT RESOLVED, that Resolution No. 159-89 and Resolution No. 336-91 are hereby rescinded; and

BE IT FURTHER RESOLVED, that whenever the County Treasurer, the Director of Real Property Tax Services, or the County Attorney becomes aware of a tax certiorari or tax exempt proceeding in which it might be appropriate for the County to intervene, such matter shall be reviewed by the Chairperson of the Legislative Committee on Planning, Environmental Management and Real Property Committee, the Deputy County Manager/Commissioner of Management and Budget, the County Treasurer, the Director of Real Property Tax Services, and the County Attorney and, if such group shall determine such intervention is in the best interests of the County, they shall seek approval from the County Legislature for such intervention; and

BE IT FURTHER RESOLVED, that in the event the County Legislature shall authorize such intervention, the County Attorney's Office shall handle such matter and shall advise the County Legislature if appropriations for additional resources, i.e., outside counsel, appraisers, experts and the like, are necessary to properly prosecute the matter.
