### RESOLUTION NO. INTRODUCED BY THE MANAGEMENT AND BUDGET COMMITTEE TO APPROVE A SULLIVAN COUNTY REVOLVING LOAN

WHEREAS, the Sullivan County Division of Planning & Environmental Management ("Division") oversees the County Main Street Main Street Business Revolving Loan Funds funded through grants received from the New York Governor's Office of Small Cities; and

WHEREAS, the Division has submitted the loan report to the Sullivan County Revolving Loan Fund Advisory Board; and

WHEREAS, the Advisory Board has considered such loan report and accompanying financial information and approved by majority the loan request listed below contingent upon certain conditions as outlined in the loan commitment letter.

RESOLUTION INTRODUCED BY GOVERNMENT SERVICES COMMITTEE CALLING UPON NEW YORK STATE GOVERNOR ANDREW M. CUOMO AND MEMBERS OF THE STATE LEGISLATURE TO REQUIRE A SUBSTANTIAL INCREASE OF THE COUNTY DEPARTMENT OF MOTOR VEHICLE REVENUE WITH THE STATE

WHEREAS, 51 of 62 New York Counties are mandated by the State to operate a local Department of Motor Vehicles Office ("DMV"), and

WHEREAS, local DMV offices process many no fee transactions on behalf of the State and provide numerous customer services, and

WHEREAS, under current law, the Sullivan County Clerk pays 87.3% of all fees collected from the work required by the DMV office, and

WHEREAS, the remaining 12.7% County share has not been increased since 1999, yet the amount of work required by the DMV office has increased in the same time period, and

WHEREAS, increasing the County DMV revenue sharing rate with the State will not result in any increased cost of fees to local residents or taxpayers and will provide counties with the needed revenue to continue to provide necessary local government services, and

WHEREAS, there is a clear inequity present when a County DMV provides all the services, including overhead and staffing to fulfill these DMV needs for State residents, yet the State is paid 87.3% of the revenue generated from said services.

**NOW, THEREFORE, BE IT RESOLVED,** that the Sullivan County Legislature calls upon Governor Andrew M. Cuomo and members of the State Legislature to require a substantial increase of the County DMV revenue with the State, and

**BE IT FURTHER RESOLVED,** that the Clerk to the Sullivan County Legislature forward certified copies of this resolution to Governor Andrew M. Cuomo and our representatives in the New York State Legislature

RESOLUTION NO. \_\_\_\_\_\_ INTRODUCED BY MANAGEMENT AND BUDGET COMMITTEE AUTHORIZING SULLIVAN COUNTY COMMUNITY COLLEGE TO REQUEST FUNDS FROM THE STATE UNIVERSITY OF NEW YORK COMMUNTIY COLLEGE CAPITAL PROGRAM FUND FOR ENERGY SAVINGS IMPROVEMENTS AND RESCINDING RESOLUTION NO. 437-14 AND RESOLUTION 426-14

WHEREAS, The County of Sullivan, as sponsor of Sullivan County Community College, may accept funds other than county funds as its match for state capital funds; and

WHEREAS, Sullivan County Community College will benefit from a NYSERDA grant and other private funds in the amount of Five Million (\$5,000,000) Dollars for campus energy savings improvements including the installation of a solar field; and

WHEREAS, the 2015 – 2016 New York State enacted budget for community college capital programs will include Ten Million (\$10,000,000) Dollars for campus energy savings improvements; and

WHEREAS, an additional Five Million (\$5,000,000) Dollars in energy-related capital projects will be reimbursed at One Hundred (100%) Percent of project costs up to Five Million (\$5,000,000) Dollars; and

WHEREAS, NY Education Law §6310, Section 10 permits Sullivan County to apply for matching funds through SUNY for the New York State share of projects that are normally permitted within an approved capital construction budget; and

WHEREAS, the Board of Trustees of Sullivan County Community College approves this project and the use of the NYSERDA grant and private funds as the County's match for approved State Capital Funds.

**NOW THEREFORE BE IT RESOLVED**, that the Sullivan County Legislature hereby adopts this resolution approving the energy savings improvements project for Ten Million (\$10,000,000) Dollars and authorizes Sullivan County Community College to request reimbursement up to 50% of eligible project costs up to Five Million (\$5,000,000) Dollars from the State of New York through the Dormitory Authority of the State of New York or directly from the State of New York, dependent upon the State appropriation backing the project; and

**BE IT FURTHER RESOLVED,** that Resolution No. 437-14 and Resolution 426-14 previously passed for the same project under a different project name and project amount are hereby rescinded; and

**BE IT FURTHER RESOLVED**, that no funds from the County's General Fund should be committed for this purpose.

RESOLUTION NO. INTRODUCED BY THE PUBLIC WORKS COMMITTEE TO AUTHORIZE EXECUTION OF CONTRACT BETWEEN NATIONAL PARK SERVICE ("NPS") AND THE COUNTY OF SULLIVAN ("COUNTY")

WHEREAS, the County owns and operates the D&H Canal Interpretive Center, located on the site of D&H Lock 50 remains at Bova Road in the Town of Mamakating; and

WHEREAS, a primary intention of the exhibits within the Interpretive Center is canal technology; and

WHEREAS, the NPS has a large scale model of the Roebling Delaware Aqueduct, of the former D&H Canal, which is a beautiful interpretation of canal technology; and

WHEREAS, the NPS is currently seeking an alternative location for this model and has completed a site survey of the D&H Interpretive Center.
