RESOLUTION INTRODUCED BY LUIS ALVAREZ TO CREATE ONE (1) PROPERTY TAX SUPERVISOR/TAX ENFORCEMENT OFFICER IN THE COUNTY TREASURER'S OFFICE

WHEREAS, it is projected that there will be a vacancy in the Property Tax Supervisor/Tax Enforcement Officer in the County Treasurer's Office, and,

WHEREAS, the County Treasurer has requested an additional Property Tax Supervisor/Tax Enforcement Office position be created to prevent a disruption in service within the department, and

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature hereby authorizes the creation of one (1) Property Tax Supervisor/Tax Enforcement Officer position in the County Treasurer's Office with a salary set in accordance with the provisions of the Teamsters Collective Bargaining Agreement, and

BE IT FURTHER RESOLVED, the Sullivan County Legislature gives approval to fill the position and any backfills that may result.

RESOLUTION NO. -16 INTRODUCED BY CATHERINE OWENS, CHAIR OF AGRICULTURE & SUSTAINABILITY POLICY COMMITTEE SUPPORTING THE SULLIVAN CATSKILLS FARMERS MARKET PROMOTION PROJECT

WHEREAS, pursuant to Resolution 196-15, the County was awarded \$96,595.66 through the USDA Farmers Market Promotion Program to promote Farmers Markets in Sullivan County; and

WHEREAS, the Sullivan Catskills Farmers Market Promotion Project is a partnership between the County of Sullivan, Cornell Cooperative Extension Sullivan County, Sullivan County Visitor's Association and the existing Farmers Market Managers who have come together to promote Sullivan County farmers markets; and

WHEREAS, the Sullivan Catskills Farmers Market Project aims to promote Sullivan County farmers markets, increase attendance at farmers markets, enhancement of tourism opportunities and provide support for our agricultural economy; and

WHEREAS, as part of the Farmers Market Promotion Project, a logo has been developed to assist with the marketing and branding for the overall project, and

WHEREAS, the Sullivan Catskills Farmers Market Promotion Project supports the implementation of the 2014 updated Sullivan County Agriculture and Farmland Protection Plan; and

WHEREAS, the Sullivan Catskills Farmers Market Promotion Project comes at a critical time in Sullivan County where there is momentum to support and enhance our agricultural community; and

WHEREAS, the Sullivan Catskills Farmers Market Promotion Project has created a County Wide branding for the Sullivan County farmers markets; and

WHEREAS, it is the desire of this Legislature to memorialize its support for the Sullivan Catskills Farmers Market Promotion Project and the County Wide farmers market branding.
