III. APPROVAL OF MINUTES

Mr. Barbuti made a motion to approve the minutes of the special meeting held on December 13, 2012. The motion was seconded by Mr. Walter, the Board voted and the motion was unanimously carried.

V. OLD BUSINESS

Ms. Brylinski advised that the proposed 2012 budget is in the format required by the PARIS system. There was a brief discussion regarding the proposed budget. On a motion by Mr. Barbuti, seconded by Mr. Gold, the Board voted and the proposed 2012 budget was unanimously passed.

VI. NEW BUSINESS

Ms. Brylinski advised that as per the NYS Public Authorities Act the SCFC must submit a Mission Statement and a Performance Measurement review to the NYS Authorities Budge Office ("ABO"). There was a brief discussion regarding this requirement. The Board unanimously agreed to authorize Ms. Brylinski to submit it, as presented.

Ms. Brylinski went on to advise that as per the 2009 Public Authorities Reform Act, the SCFC is required to conduct an annual evaluation of its own performance. She advised that there is really not much to discuss being the Board was just appointed within the past month. The results of the discussion will be submitted to the ABO.

Mr. Barbuti questioned if the SCFC had a web site yet. Ms. Brylinski replied that not yet, but soon a web site will be created. The new web site will follow the same format as the IDA, where applicable.

Mr. Garigliano asked if the an executive session be called to discuss the contract associated with the sale of County owned land. On a motion by Mr. Barbuti, seconded by Mr. Walter, the Board voted and unanimously agreed to go into executive session at approximately 9:42 A.M. Manager Fanslau and Mr. Steingart were asked to stay for the executive session.

On a motion by Mr. Gold, seconded by Mr. Alport, the Board unanimously voted to come out of executive session at approximately 10:17 A.M.

Millennium Pipeline Loan Fund – Established 2009 – Transferred from the IDA to the Sullivan County Funding Corporation on December 13, 2011

The primary objectives of the Millennium Pipeline Revolving Loan Fund (MRLF) are to facilitate the establishment or expansion of business activity within the County of Sullivan and create employment opportunities; to encourage development of new business concepts and ideas; and to supplement the cost of a borrower hiring a qualified County high school student. A well thought out business plan is required.

The MRLF is intended to supplement an owner's equity in order to facilitate financing with traditional financing sources. Therefore, MRLF assistance shall be no greater than the minimum amount necessary to facilitate the business activity. Applicants must demonstrate that other private and public sources of debt and equity have either been maximized or are inappropriate, unaffordable, or otherwise unavailable. It is generally expected that the amount of MRLF assistance will not exceed fifty (50%) percent of the total amount of the required capital.

Loan requirements include:

- Loan will not exceed \$75,000, but not more than 50% of the project cost.
- Eligible projects: Businesses within Sullivan County.
- Eligible Uses: Fixed assets.
- One new employee must be hired for each \$20,000 borrowed.
- Applicant must demonstrate that other private and public sources of debt and equity have either been maximized or are inappropriate, unaffordable, or otherwise unavailable.
- Minimum credit score of 550, or at the discretion of the Sullivan County Funding Corporation Board.
- Must show ability to repay the loan and offer collateral.
- Terms: Interest rate and repayment terms at the discretion of the Sullivan County Funding Corporation Board.
- Application Fee: Non-refundable \$250.
- Agency Fee: Greater of 1% of loan amount or \$250.

• Attorney Fee: Greater of 1% of loan amount or \$500.

In 2011 the following loans were approved by the Board:

- Jane Axemethy, The Bake Shop, May 31, 2011, \$20,000.
- David Appel, Appel Produce, August 26, 2011, \$25,000.
- Carmine's Meat Market, Sept 7, 2011, \$30,000.
- K. Cee's Catering, Sept 9, 2011, \$50,000.
- Jennifer Grimes, Eureka Market, Sept 14, 2011, \$75,000.

All these loans were transferred to the IDA's regular Revolving Loan Fund late in 2011.

The only other loan recipient we have on the books is Sara Ingber, Sara's Gourmet, that was given by our Revolving Loan Fund in the amount of \$40,000 in 2009.

In July of 2011, the Board approved a three year agreement with Hudson Valley AgriBusiness Development Corporation, with \$25,000 paid in 2011, and \$25,000 earmarked for each of the next two years.

As of April 11, 2012, the amount currently in the Sullivan County Funding Corporation's Millennium Fund account is \$384,109. With \$50,000 dedicated to the Hudson Valley AgriBusiness Development Corporation for the next two years, the usable balance is **\$334,109**.

The Millennium Pipeline Project will fund the fund in the amount of \$100,000 for the next seven years.
