WHEREAS, the Center for Workforce Development is responsible for the implementation of the Title I provisions of the federal Workforce Investment Act of 1998, and

WHEREAS, the Center for Workforce Development is looking to bid the provision of certain services for the adult, dislocated worker and youth populations, and

WHEREAS, the Sullivan County BOCES ("BOCES") submitted the winning bid, and

WHEREAS, BOCES services meet all of the requirements under the Workforce Investment Act, and

WHEREAS, the BOCES will provide comprehensive employment, education and training services to eligible participants from July 1,2012 through June 30, 2013, and

WHEREAS, amount to be charged by BOCES for the above referenced services shall not exceed \$50,000.00.

NOW, THEREFORE, BE IT RESOLVED, that the County Manager is hereby authorized to execute an agreement with BOCES as described above, said agreement to be in the form approved by the County Attorney, and

BE IT FURTHER RESOLVED, that the above contract will be contingent upon the County receiving the Federal allocations.

<u>ACTIVITY REPORT – JUNE 2012</u> COUNTY OF SULLIVAN INDUSTRIAL DEVELOPMENT AGENCY

May 31, 2012

Earlier this year USDA Rural Micro-entrepreneur Assistance Program (RMAP) funding become available again after being suspended by the Federal government late last year. The IDA held a closing with the USDA on May 10, 2012. The dissemination of loan information regarding the new program will be available in the coming months.

Work continued with Holiday Mt regarding the New York State Dormitory Authority's proposed funding for infrastructure related to an expansion project.

Staff assisted the County with the review of Micro Enterprise Assistance Program loan applications. Applicants that do not make the initial cut for that program may be illegible for assistance through the Sullivan County Funding Corporation's Millennium Loan Fund.

A regular meeting of the IDA was held on May 8, 2012. At that meeting the Board approved resolutions needed to close on the RMAP program with the USDA, and it had its annual report/discussion of the Agency's audit by Andrew Arias of Cooper, Niemann & Company. No faults were found with the Agency. Additionally, Mr. Arias reported on the audit of the Sullivan County Funding Corporation. He also concluded that no faults were found with that Agency.

A special meeting of the IDA was held on May 18th with the sole purpose of approving an amendment of the RHH Land project documents.

The Red Meat Facility project's Technical Consultant, Glenn Smith, submitted documents to the US Department of Commerce for approval prior to releasing a Notice to Bidders for the site work phase of the construction plan. The release of the Notice is expected to occur sometime in June.

- SCVA'S 2012 Visitors Guide is being distributed to visitors centers, web and 800 requests and ad placement requests. To date over 30,000 guides have been distributed.
- Tentative date for the Sullivan County Catskills Outdoor Expo is March 22 & 23, 2013. This will coincide with the State Conference of Duck Unlimited.
- A recent visit from a free lance writer was recently published in Passport Magazine, an international gay travel publication, for the May edition and on Fodor Travel. The writer has also started a dedicated trip planner for the G&L visitor and Sullivan County properties have the opportunity to work with him to offer accommodation packages.
- SCVA hosted a film crew on April 29 -May 2 from the UK to promote fishing and attractions in the Sullivan County Catskills. The trip with the help of the Roscoe community and several of our members throughout the county gave Wychwood, a UK supplier of fishing gear, THG Holiday and Virgin Atlantic an impressive visit and they will be promoting the Sullivan County Catskills as a premier destination. They are running a contest and have had many sign up for a chance to win a trip to NYS.
- SCVA is implementing several updates to the main site, social media and digital advertising venues for 2012 including driving tours, packages and social campaigns.
- SCVA has had several film and TV inquires interested in different locations to shoot.

- SCVA now has an inbound tour operator, Big V Tours, that is working on bringing groups from NYC to the Sullivan County Catskills. The two trips available at this time are an outdoor adventure package and a Peace & Love tour. Plans are to incorporate overnight packages to include stay & play, foliage and spirit tours. Big V Tours and SCVA will be working to create packages that help extend the season.
- SCVA implemented a Restaurant Week in May with the restaurants of the Sullivan County Catskills. SCVA hopes to have results in through a survey of participating restaurants to measure the success.
- SCVA is soliciting package rates from our golf courses to use with a Stay & Play package to entice golfers to come and utilize our courses.
- FoodStock was successful and SCVA is promoting Farm Stock to weekly to grow this event.
- SCVA is working with the Arts community to further promote last year's Arts & Cultural Guide.
- With the Tourism Marketing Committee, SCVA is looking to create a multi-day event during the shoulder season to create interest in the arts. A "passport program" will be instituted for 2012 so visitors will be enticed to visit many of the venues during the season.
- SCVA and the Tourism Marketing Committee are compiling all of the unusual aspects of Sullivan County to use for promotion and geo caching.
- SCVA and the Committee are working with Digit and the Arts Alliance to create a new film festival for this fall as well as expanding upon the wine festival at Bethel Woods.
- SCVA is asking visitors to submit their vacation videos to SCVA for promoting on the web site.
- SCVA continues to work with Renaissance on the Coach Bus Stop and SC airport project.
- SCVA continues to send e-blasts and media updates to an ever growing e-mail database.
