Proposed Law Enforcement Commission

The County Legislature should develop a Law Enforcement Commission that will comprehensively review the law enforcement needs throughout the County, starting with an inventory of available resources from the New York State Police to the Sheriff's Office to Town and Village Police Departments and constabularies. The County Legislature has placed a priority on public safety, but the cost in the aggregate of the law enforcement agencies should be analyzed, with a plan to develop a sustainable revenue source to comprehensively fund public safety for the future. Moreover, the Legislature will need to make a policy determination on the level of law enforcement services provided at the County level that can be fiscally sustainable moving forward in 2013 and beyond.

The Law Enforcement Commission would analyze the fiscal prudence of providing certain levels of law enforcement services at the County level, supported by county tax revenues, as opposed to utilizing the services of the New York State Police and having those services funded at the State government level, or provided at the Town or Village level, with Town or Village tax revenues supporting the law enforcement services.

A study of the assignments of each level of law enforcement would need to be charted to reduce duplication of effort, improve efficiencies, and control the costs associated with Law Enforcement.

Should Sullivan County maintain the current level of Law Enforcement services, there would need to be an increase in the County's property tax levy to support the current level of services, as well as any increase in the level of services provided at the County level.

RESOLUTION NO._____ INTRODUCED BY THE EXECUTIVE COMMITTEE TO AUTHORIZE THE PREPARATION AND SUBMISSION OF A SULLIVAN RENAISSANCE PROGRAM GRANT APPLICATION, OFFERING FUNDS, FOR A COMPOSTING PROJECT

WHEREAS, the Adult Care Center has a desire to apply for and accept a Sullivan Renaissance grant; and

WHEREAS,; the Adult Care Center has a desire to use the grant money to initiate a composting project at the ACC, and

RESOLUTION NO. INTRODUCED BY THE EXECUTIVE COMMITTEE TO APPOINT A MEMBER OF THE SULLIVAN COUNTY AGRICULTURAL AND FARMLAND PROTECTION BOARD

WHEREAS, Article 25AA of the Agriculture and Markets Law requires that one seat on the Sullivan County Agricultural and Farmland Protection Board (Board) be held by a county cooperative extension agent; and

WHEREAS, pursuant to Resolution No. 80 of 2012, Patricia Westenbroek of Cornell Cooperative Extension Sullivan County was appointed to the Board; and

WHEREAS, Patricia Westenbroek no longer serves as county cooperative extension agent with Cornell Cooperative Extension Sullivan County; and

WHEREAS, Elizabeth Higgins currently serves as a county cooperative extension agent with Cornell Cooperative Extension Sullivan county; and

WHEREAS, the Board recommends that Elizabeth Higgins be appointed to the Board to replace Patricia Westenbroek as a required member of the Board.

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature hereby appoints Elizabeth Higgins to the Board, for a term commencing immediately and ending at the end of her term as county cooperative extension agent.
