RESOLUTION INTRODUCED BY GOVERNMENT SERVICES COMMITTEE

RESOLUTION TO AUTHORIZE SULLIVAN COUNTY RISK MANAGEMENT TO CONTRACT WITH HARBRIDGE CONSULTING GROUP TO PROVIDE ACTUARIAL VALUATION SERVICES IN RELATION TO POST RETIREMENT MEDICAL BENEFIT PLAN AND THE REQUIREMENTS OF GASB 45.

WHEREAS, Sullivan County provides postretirement benefits which encompasses (1) the NYSHIP/Empire medical plan, seven (7) union/non-union employee groups and various contribution schedules for approximately fourteen hundred (1400) county employees, retirees and dependents of retirees, and

WHEREAS, Sullivan County is seeking an actuarial valuation of these postretirement benefits under GASB 45, Accounting and Financial Reporting by Employers for Post Employment Benefits other than pensions, and

WHEREAS, Sullivan County needs to fulfill this mandated requirement, and

WHEREAS, a proposal was received from Harbridge Consulting Group, in accordance with Request for Proposal, R-12-16, dated August 17, 2012, and

WHEREAS, Risk Management approves said proposal and recommends that a contract be executed.

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature authorizes the County Manager to contract with Harbridge Consulting Group to provide actuarial valuation services to fulfill the requirements of GASB 45 at a cost not to exceed \$10,600 over a two (2) year period, and

BE IT FURTHER RESOLVED, that the form of such contract be approved by the Sullivan County Department of Law.

RESOLUTION INTRODUCED BY GOVERNMENT SERVICES COMMITTEE AUTHORIZING SULLIVAN COUNTY COMMUNITY COLLEGE TO REQUEST FUNDS FROM THE STATE UNIVERSITY OF NEW YORK COMMUNITY COLLEGE CAPITAL FUND

WHEREAS, Sullivan County as sponsor of Sullivan County Community College (SCCC) may accept funds other than county funds as its match for state capital funds; and

WHEREAS, the New York State enacted budget for community college capital program included \$1,200,000 for a Complete Mainframe Computer Upgrade; and

WHEREAS, SCCC will spend a total of \$671,720 from capital chargeback funds towards the Jenzabar Computer Upgrade (Complete Mainframe Computer Upgrade); and

WHEREAS, that the Board of Trustees of Sullivan County Community College has approved this project and the use of the capital cost chargeback funds as the County's match for approved State capital funds and has requested that the Sullivan County Legislature adopt this Resolution.

NOW THEREFORE BE IT RESOLVED, that the Sullivan County Legislature hereby adopts this resolution and authorizes the Sullivan County Community College to request matching funds in the amount of \$212,800 from the State University of New York Community College Capital Program Fund.

BE IT FURTHER RESOLVED, that no funds from the County's General Fund should be committed for this purpose.
