RESOLUTION	INTRODUCED BY THE	COMMITTEE

RESOLUTION TO AUTHORIZE THE SUBMISSION OF A GOOD NEIGHBOR CITIZENSHIP COMPANY GRANT APPLICATION FOR THE SULLIVAN COUNTY BUREAU OF FIRE;

WHEREAS, the Sullivan County Bureau of Fire seeks to apply for a Good Neighbor Citizenship Company Grant from State Farm Insurance; and

WHEREAS, the Good Neighbor Citizenship Company Grants fund Safety Grants with an emphasis on home safety and fire prevention, as well as disaster preparedness and disaster recovery; and

WHEREAS, the Sullivan County Bureau of Fire proposes to submit an application to fund the purchase of thirty laptop computers with accompanying educational equipment to be placed in the SC Emergency Services Training Center to be used in training and educational programs for local emergency responders, as well as by the Emergency Operations Center in the event of a disaster.

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature hereby authorizes the County Manager, Chairman of the County Legislature, and / or their authorized representative (as required by the funding source) to execute any and all necessary documents to submit the Good Neighbor Citizenship Company Grant application for funding; and

BE IT FURTHER RESOLVED, that the Sullivan County Legislature hereby authorizes the County Manager, and / or Chairman of the County Legislature (as required by the funding source) to accept the award, and enter into an award agreement or contract to administer the funding secured, in such form as the County Attorney shall approve; and

BE IT FURTHER RESOLVED, that should the Good Neighbor Citizenship Company Grant funding be terminated, the County shall not be obligated to continue any action undertaken by the use of this funding.
