**RESOLUTION NO. INTRODUCED BY THE PUBLIC SAFETY AND LAW ENFORCEMENT COMMITTEE TO EXECUTE RECIPROCITY AGREEMENTS FOR ELECTRICAL LICENSING**

**WHEREAS**, the Electrical Licensing Board has recommended reciprocal electrical licensing with Greene County, NY, City of Poughkeepsie, City of Kingston, City of Port Jervis, City of Newburgh and City of Troy, New York.

**WHEREAS**, the Sullivan County Legislature must authorize such reciprocity.

**NOW, THEREFORE, BE IT RESOLVED**, that pursuant to 103-25A of the Sullivan County Code, the County Manager is authorized to execute reciprocity agreements with Greene County, NY, City of Poughkeepsie, City of Kingston, City of Port Jervis, City of Newburgh and City of Troy, New York, until further resolution by the Legislature.
