Agriculture Report May 2016

1. Agriculture and Farmland Protection Board:

- **Agricultural Districts:** A public hearing for the inclusion of parcels into Agriculture District #4 was held on June 16th. A resolution is set for the Ag and Sustainability Committee and the Full Legislature for their July meetings.
- Agriculture Zoning: Several municipalities in Sullivan County are undergoing zoning and comprehensive plan
 updates. The board is here to provide assistance and is in the process of informing municipalities about possible
 funding from NYS Agriculture and Markets for municipalities regarding ag zoning.
- **Training:** The ag board is going to work with the Planning Department, CCE and NYS Agriculture and Markets to provide training in the fall to municipalities, farmers and the public regarding agriculture districts and right to farm laws.

Educational Programs:

Vegetable Farm Tour: 15 participants took part in a tour of John Gorzynski's vegetable farm. Topics examined were marketing, weed management, high tunnels, crop techniques and tillage.

Dairy Processing Project:

The Planning Department and Purchasing are currently working through the bidding process for the project.

Farmers Market Promotion:

Project: CCE and Planning are working with the Farmers Market Managers for all of the farmers markets in Sullivan County, SCVA and Public Health to develop a marketing plan for 2016 – 2017, in order to increase attendance at our farmers markets.

- Currently working on market manager surveys, public surveys and vendor surveys.
- We are launching the project and new branding during farmers market week (8/7 8/13) at the Monticello market on Monday August 8^{th} at 12pm. More details and invitations to come.
- Next steps: to analyze all of the information gathered and put together the marketing plan.
- As part of the project we have provided educational programming at farmers market on: nutrition, cooking demos and composting.

Ag Reports & Market Reports: CCE provided weekly ag market reports for Thunder 102

Farm to Market/Institution Project:

- CCE is currently collecting information for the USDA Farm to Institution Planning Project. As part of the project
 we are surveying farmers, institutions and distributors, this also includes conducting farm visits. In addition, we
 are developing a better inventory of the farms located in Sullivan County. To date, we have surveyed over 25
 farmers, 4 schools and 1 distributor. We anticipate interviewing 3 more large scale institutions, 1 more
 distributor and 10 more farmers by August. The planning project will be completed by September. Once
 complete, we will work on implementation.
- As a result of the information gathered so far, CCE is currently developing farmer training scheduled for fall/winter.

Agri-Business Retention and Expansion Program:

As part of this program we have accomplished the following:

- Visited 20 farms. *40 to date. With a number of visits scheduled for July.
- Created 150 farm business resource packets. We have handed out approximately 60.
- We are currently working on a Sullivan County farm resource manual.
- Developing a young dairy farmer discussion group and a new/beginner farmer discussion group.
- Developing agri-business workshops for the fall such as Technology for Farmers, Agri-Tourism, Farm law,
 Quickbooks, Food Safety classes, a dairy regulations for value added production
- We are working with dairy farms on exploring value added production.
- We are working with 3 farms on developing business plans.

SC Office of Sustainable Energy (OSE) Activities Report for July 2016 Reporting on June 2016

I. Zoning for Solar in Sullivan County

A lot of OSE activity over the past month has focused on helping our towns understand the various issues surrounding the need to create effective zoning for large scale solar installations. This is imperative as we move towards projects that will help us meet an increasing percentage of the County's residential, commercial and municipal energy load from locally-sited renewable energy sources. Key issues are emerging, and the County has a vital role to play in ensuring that the resources are used wisely and in a way that supports and enhances the County's goals for public health and economic development.

We are working with SC Division of Planning and Environmental Management (SC DPEM) to interpret the model zoning law provided by the NY SUN program and to help towns tailor the model to their needs.

- Reviewed the model law and toolkit
- Met with DPEM to review zoning laws proposed by 2 towns
- Working with DPEM to develop a workshop on solar zoning, scheduled for August 3 2016.
- Stephen Stuart gave a presentation to the Town of Tusten town board on June14th.
- Stephen Stuart and Carol Roig gave a presentation to the Upper Delaware Scenic Byway on June 27th.
- We have initiated a discussion with the Division of Planning and the County Manager's office to explore
 ways we can collaborate to develop a coherent renewable energy plan for Sullivan County that is
 responsive to community concerns, identifies optimal and appropriate locations for large scale solar, and
 facilitates the robust build-out of solar and wind resources to meet the County's needs.

II. ENERGY MANAGEMENT FOR SC FACILITIES

Work on the following priority projects is ongoing:

NYPA project for HVAC replacement at SC Government Center: An interior lighting walkthrough of the Government Center took place in June. NYPA is identifying opportunities to reduce number of fixtures and improve lighting design as part of a change-out to LED lighting at the Government Center.

Hybrid Vehicles for SC Fleet: We are working to identify model policy statements for integration of energy efficient vehicles into the County fleet.

Solar Installation at the Liberty Health and Community Services Campus: We are still anticipating completion of installation by the end of July.

Adult Care Center Energy Efficiency Measures: The US Department of Energy has enacted new standards for Package Terminal Heat Pumps (PTHP) units which will be on the market in November 2016. When these units are available, we will work with DPW to determine the best value units, costs, and a pre-authorization agreement made with NYSEG to have NYSEG commit the incentive funds.

III. SULLIVAN COUNTY COMMUNITY CHOICE AGGREGATION (CCA)

In light of the Public Service Commission (PSC)'s decision regarding acceptable models for CCA projects, SASD is researching program configurations that will achieve the goal of a county-wide CCA for Sullivan County. Our priorities remain: energy cost reduction for all County residents and small businesses, implementation of local renewable energy generation, and full accessibility for LMI residents. SASD has provided the County Attorney with a summary of the PSC decision, and we are working on a memorandum that outlines the options we are considering.

IV. Update of the SC Climate Action Plan

Carol Roig met with Heather Brown on June 14th to map out actions for an update of the Climate Action Plan. The update will take the form of an addendum that documents progress on goals and benchmarks in the six topic areas (Energy, Transportation, Materials Management, Land & Water Use, Public Health and Emergency Planning) laid out in the 2014 plan. We will develop new goals for County government operations in the categories of materials management (waste management and purchasing decisions) and public health, in collaboration with appropriate County staff. OSE is also researching model policy statements for fuel-efficient vehicles fleets and green purchasing.

We will map out a process for updating the GHG inventory for County operations. The update will calculate GHG and cost reductions relating to large scale projects such as the solar array in Liberty and the new PPA with Gravity Renewables, as well as energy efficiency measures taken. For the GHG inventory update, we will use 2017 energy use and cost data to capture the cost reductions and energy efficiency improvements made possible by these large scale projects.

V. CLIMATE SMART COMMUNITIES

The Town of Highland has developed a 6 month action plan to address the following priorities:

- Energy Efficiency for Town Buildings: SASD will provide preliminary walk-throughs of town buildings.
- GHG Inventory: Highland will use 2007 billing data to establish a baseline year.
- Community Outreach: The Energy Committee will develop a communications plan for informational outreach to Town residents, using the Town of Highland web site and Facebook page as well as strategies for town residents who may not use social media. The Committee will offer to host a community forum on solar energy, in support of Catskill Mountainkeeper's "Solarize Sullivan" campaign, which will use bulk purchase strategies to help residents go solar.
- Unified Permitting Process for Residential Scale solar installations: The Highland Town Board will consider a draft resolution in July.
- Zoning for Large Scale Solar Installations: The model ordinance and toolkit was circulated for the Committee to review. The Committee will work with the Highland Zoning Rewrite Task Force to assist with this issue.

VI. Other Community Education and Outreach

Catskill Mountainkeeper has invited SASD to be a community partner in their Solarize Sullivan project, a bulk purchase program that seeks to reduce soft costs for residential and small business solar energy installations. SASD expects to provide assistance with outreach and education efforts to help potential participants understand the basics of solar energy and make informed decisions about their solar opportunities.

RESOLUTION NO. INTRODUCED BY THE AGRICULTURE AND SUSTAINABILITY COMMITTEE TO ISSUE A NEGATIVE DECLARATION PURSUANT TO THE NEW YORK STATE ENVIRONMENTAL QUALITY REVIEW ACT REGARDING THE ADDITION OF PARCELS OF REAL PROPERTY TO EXISTING CERTIFIED AGRICULTURAL DISTRICTS WITHIN SULLIVAN COUNTY

WHEREAS, The Sullivan County Legislature has the authority under New York State Agriculture and Markets Law Section 303-b to include additional parcels in the existing certified Agricultural District No. 4 on a yearly basis; and

WHEREAS, the New York State Department of Agriculture and Markets has consented to the Sullivan County Legislature being declared lead agency with respect to the environmental review of the proposal to add parcels to Sullivan Agricultural District No. 4; and

WHEREAS, a short form Environmental Assessment (attached hereto) has been prepared which concludes that the proposal to add parcels, pursuant to Resolutions to be adopted by the Sullivan County Legislature, to Sullivan County Agricultural Districts No. 4 will not have a significant adverse impact on the environment and conculdes that the County Legislature issue a Negative Declaration.

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature hereby accepts the Environmental Assessment described in the SEQRA Environmental Assessment Form (attached hereto); and

BE IT FURTHER RESOLVED, that the Sullivan County Legislature hereby issues a Negative Declaration pursuant to the provisions of the New York State Environmental Quality Review Act, with respect to the proposal to add parcels to Sullivan County Agricultural District No. 4; and

BE IT FURTHER RESOLVED, that the Sullivan County Legislature authorizes the Chairman of the Legislature to execute the Environmental Assessment Form.

RESOLUTION NO. INTRODUCED BY THE AGRICULTURE AND SUSTAINABILITY COMMITTEE TO INCLUDE VIABLE AGRICULTURAL LAND IN AN EXISTING CERTIFIED AGRICULTURAL DISTRICT WITHIN SULLIVAN COUNTY

WHEREAS, Section 303-b of the Agriculture and Markets Law authorizes the inclusion of viable agricultural land into certified agricultural districts; and

WHEREAS, the County of Sullivan's Agricultural & Farmland Protection Board has recommended that the parcels listed below be added to the existing certified Agricultural District No. 4 within Sullivan County; and

WHEREAS, a public hearing was held on the inclusion of the parcels into the existing certified Agricultural District No. 4 on June 16th, 2016 at which time all comments were heard by the Sullivan County Legislature; and

WHEREAS, all comments and considerations brought to the attention of the Sullivan County Legislature and the Sullivan County Division of Planning and Environmental Management were considered during all phases of the inclusion process, including but not limited to the environmental review process, in determining whether or not the parcels should be included in the existing certified Agricultural District No. 4.
