# ACTIVITY REPORT -OCTOBER 2016 COUNTY OF SULLIVAN INDUSTRIAL DEVELOPMENT AGENCY, SULLIVAN COUNTY FUNDING CORPORATION, THE SULLIVAN COUNTY INFRASTRUCTURE LOCAL DEVELOPMENT CORPORATION

October 27th, 2016

During October, the IDA, SCFC and TSCILDC all adopted their budgets for fiscal year 2017. Staff devoted considerable time to the development of these budgets in recent weeks, and all three budgets have now been submitted to the New York State Authorities Budget Office via the Public Authorities Reporting Information System (PARIS), in accordance with New York State law.

At the October 17<sup>th</sup> meeting of the IDA Board, Board members and staff discussed a proposed new tax abatement program for community solar projects. The Board also began a discussion of the proposed sale of the Crystal Run Healthcare property from one real estate investment trust to another. The meeting was recessed, and we anticipate that the Board will continue these discussions when the meeting reconvenes on November 2<sup>nd</sup>.

On October 20<sup>th</sup>, IDA staff and USDA-Rural Development staff toured the facilities of Catskill Distilling Company, Ltd., Roscoe NY Beer Company, and Prohibition Distillery LLC. Through USDA-Rural Business Development Grants awarded to the IDA in 2015, these three businesses now lease equipment from the IDA. All three report that the new equipment is essential to the expansion of their businesses. Administration of these grants was a major focus of staff time during the past two months, and we have submitted three significant reimbursement requests for USDA review and approval.

During the October 20<sup>th</sup> visits, IDA staff also conducted annual reviews of Catskill Distilling and Roscoe Beer. These two businesses are loan recipients under the IDA's Rural Microentrepreneur Assistance Program.

IDA staff is currently working with three loan applicants to develop and refine their application packages. Staff is also working with a potential applicant for tax abatements.

During November, IDA staff will begin to send PILOT bills to our projects. PILOT calculations, billing, collection, and distribution to the taxing jurisdictions will be our highest priority and main focus through March 2017.

At its October 17<sup>th</sup> meeting, The Sullivan County Infrastructure Local Development Corporation began a discussion of proposed water storage improvements to be made by the Village of Monticello. Increased water storage capacity is necessary for the development of the proposed water park at Adelaar. Because TSCILDC owns the infrastructure associated with the Adelaar project, TSCILDC will be the party to contract with the Village for the construction of the water storage improvements. The October 17<sup>th</sup> meeting was recessed and we anticipate that a resolution will be presented for the Board's consideration on November 2<sup>nd</sup> when the meeting reconvenes.

## Report to Legislature – November 2016

## A. General Operations

### Activities

- We are moving ahead once again with WE SHIP 24/7, a specialty fulfillment house for craft wines, micro brewery/ distilling products and specialty gift club vendors. We will be meeting with the principals to move forward with an expansion of at least 33,000 sq. ft. which would double the current operational footprint and jobs associated.
- I have met with the Town of Liberty to discuss moving forward with a corridor analysis relative to the Old Rout 17 area between Twin Bridge Road and just past the Town of Thompson line. Similar in part to the East Broadway effort Commissioner of Planning Freda Eisenberg is undertaking, the effort will provide the foundation and pro forma assumptions to move forward with a GEIS of the entire corridor for Industrial Commercial end users. The Town has formally asked us to work with their engineer in order to secure funding and begin the process. This effort will be multi-municipal as we have verbal cooperation signals from the Village of Liberty for access to infrastructure and the Town of Thompson as there are several sites near Nonnis that would be suitable for development moving forward. This corridor is at the heart of the Sullivan County physically and is located immediately proximate to I-86/NYS 17 with easy access to interchanges. In order to continue to attract diverse industry sectors to the County we must begin preparing preapproved locations in order to be competitive in the region. Metcar's Aerospace Materials Division is a clear example of the Sullivan County Economic Development team can compete at regional and even national levels if we have sites ready to go.
- We have responded to an Empire State Development request for sites to locate a distribution center. Site requires access to I-86, 50 acres and other amenities. A site visit is decision pending at this time.
- The Partnership 22<sup>nd</sup> Annual Meeting and Celebration was held on October 6 from 5:30 to 8:00 at the Ramada Inn at the Sullivan in Rock Hill. The evening was full of great enthusiasm and energy for the projects currently under way and the prospects of things to come. Attitudes have definitely changed to a more can do positive thinking and its reflected in our business community and municipal efforts (i.e. Jefferson Street,)
- Economic indicators are <u>beginning</u> to show signs of the economic turnaround we have been expecting, all before any of our larger projects have opened. As you know sales tax is up significantly, and unemployment down but more interesting is real estate beginning to move again. The Board of Realtors recently reported 63 home sales in August compared to

**34** the prior year with median sales price climbing to **\$152,500** an increase of **24%.** With interest rates yet low, and demand inching past supply, this market is on the cusp of turning around as well.

- Local Investment this construction season has revealed a very positive dynamic for the
  county. Organic local investment has taken place throughout the county, underscoring
  investor confidence in our market. From the Western in Callicoon, to Jefferson Street in
  Monticello and other parts of the county the local investment is beginning to make a visual
  impact on main thoroughfares. Larger developers are taking notice.
- Greek Festival we met with the group that hosts the Greek festival for the past two summers. The event is growing each year with approximately 3,000 attendees this year despite rain. A significant number are form NYC and travel here specifically for the event. They are now looking to purchase a permanent location with existing rooms and land for further development. Several sites are being considered at this time. Update: The principals continue to explore options at this time.
- We met with a developer seeking to create workforce housing to serve casino employees
  as well as the spa and future employers. The group owns several sites within several miles
  of the Montreign site, and is conducting their due diligence to determine final number of
  units, costs, price point and other issues before formally making application. Ongoing.
- Meetings: New York State Economic Development Council, Liberty Town Board, CCA, Hudson Valley Economic Development Corporation, East Broadway Development Corridor Steering Committee.

# B. **Project Updates**

## a. Corporate Attraction

- b. Small Business/Entrepreneurial Development

- We will be assisting a local small business with a heavy equipment purchase need to expand operations in his business. The firm is located in Jeffersonville. Ongoing. Awaiting updates to business plan at this time.
- Chris Lockwood from our office is working with SC Planning to once again put on entrepreneurial training program this fall.

## c. Business Expansion

We have met with principals of Formaggio cheese with assistance from Empire State Development Corporation. The company has enjoyed recent expansion of existing offerings and the successful introduction of new products in to the market place. They will be seeking to expand their facility to handle increase demand and will need an additional 40+ employees. We are working with them either as a potential CFA application or a time sensitive ESD project at this time. *Ongoing.* We are waiting for their project information worksheet along with pro forma at this time.

- e. Membership Education we will be planning the 4<sup>th</sup> annual SEQRA conference immediately after our annual meeting. At this time the date will be for this educational conference will be March 15, 2017. Look for update communiqués over the next several months. This year's conference will look to review more in depth development issues regarding the process and specific mandated reviews. Continuing education credits will be sought after for municipal professions, as well as engineers and planners.
