ACTIVITY REPORT -DECEMBER 2016 COUNTY OF SULLIVAN INDUSTRIAL DEVELOPMENT AGENCY, SULLIVAN COUNTY FUNDING CORPORATION, THE SULLIVAN COUNTY INFRASTRUCTURE LOCAL DEVELOPMENT CORPORATION

January 3, 2017

The IDA's regular Board meeting on November 14th was recessed and reconvened on November 28th. At its November 28th reconvened meeting, the Board authorized the assignment of the Sutphen East Corp. project to HVFG LLC and Hudsut LLC. Sutphen East Corp. has left its facility in the Airport Industrial Park and HVFG LLC and Hudsut LLC plan to utilize this space for value added production of agricultural products and additional frozen product storage. Also on November 28th, the Board approved an extension of the sales tax exemption period for BRR Brothers III, LLC and Sullivan County Fabrication Inc., a metal fabricating facility in the Town of Fallsburg. Finally, the Board consented to and authorized the transfer of fee title of the property that houses the Crystal Run Healthcare facility from one real estate investment trust to another. This transaction closed on December 29th.

At its regular meeting on December 12, the IDA approved extensions of the sales tax exemption periods for several ongoing projects: Metallized Carbon Corp., Veria Lifestyle Inc., Monticello Raceway Management, Inc. and Montreign Operating Company, LLC; Rock Meadow Partners, LLC; EPT Concord II, LLC; Deb El Food Products LLC; Catskill Distilling Company, Ltd.; and RJ Baker Corp. and Beaverkill Studio, Inc. These sales tax extensions are in accordance with the project documents and will facilitate the continued development of the projects as originally approved by the IDA. The Board also approved the fourth quarter payment to the Partnership for Economic Development in Sullivan County, Inc. Finally, following a thirty-day public comment period, the Board adopted an additional Uniform Targeted Tax Abatement Policy, the Community Distributed Generation Uniform Tax Abatement Policy.

December has been a busy month for staff, with the preparation of Payment in Lieu of Tax and Annual Lease statements and preparation for end-of-year data collection and reporting related to the IDA's tax abatement, loan, and grant projects and SCFC's loan projects.

Staff continues to administer all aspects of The Sullivan County Infrastructure Local Development Corporation's (TSCILDC) business. With the execution of the Water Storage Improvements Agreement and License Agreement between The Sullivan County Infrastructure Local Development Corporation (TSCILDC) and the Village of Monticello, engineering work on the water storage improvements is underway and staff is responsible for ensuring the accuracy and completeness of all payment requisitions.

We are currently working with one loan applicant and two applicants for IDA tax incentives, and we expect 2017 to be another busy year.

Report to Legislature - January 2017

A. General Operations

- As we begin 2017 there remains much optimism carried over from last year. Several
 projects that were going through the planning board process will begin construction soon.
 Although the jail project is not an attraction the impact is has on our community from a
 construction jobs, local investment and visual perspective remains very significant. Touring
 prospects around the county the site work surely adds to the overall construction activity
 taking place now and makes for a compelling case for those contemplating investing on our
 county.
- The Metalized Carbon project is proceeding steadily. I spoke with the firm last week and they anticipate beginning to hire in mid to late February. In addition another metal fabrication project is moving along which will continue to bolster the industry sector and continue to diversify job growth here.
- Chris Lockwood will be taking over our Small Business/Entrepreneurial programs in their entirety. He will be reviewing guidelines, underwriting procedures to seek improvements while bolstering the various funds through procurement efforts. Chris will have a more visible role in 2017 at many events and will be representing the Partnership as he continues his growth and progression within the organization. He represents the best of our youth and we hope he will be one of young residents who stays and makes Sullivan County his home.
- Closing the year, though we could only get November figures, and while we know there are
 those individuals who may have left the workforce all together, the trend over the last
 three years is significant, cutting unemployment nearly in half. This circumstance will only
 get better as we introduce new jobs in the coming years ahead.

B. Project Updates

a. Corporate Attraction

We have submitted three sites in response to an ESD inquiring relative to a 100,000 sq. ft distribution center. All sites are Industrial Commercial with access to I-86.

b. Small Business/Entrepreneurial Development

- The Partnership has approved a lone to Jeff Sanitation for its expansion at its existing location. We are working with the IDA to coordinate efforts and administrative next steps. The project seeks to expand its operations and complete its transfer station construction efforts.
- Chris Lockwood from our office is working with SC Planning to on an entrepreneurial training program. The series has begun and is proceeding through is full schedule.

c. Business Expansion

- We have met with the principals of We Ship Express 24/7. They will be looking to expand their operations significantly. We have been asked to provide an analysis of expanding at their current location and other locations that could increase their foot print from 33,000 sq. ft. to 100,000. Proportionate increase in employment would of course follow. The company has requested sample illustrations in order to make a prudent business decision.
- A local manufacturer will be investing in a new plant on a former food processing site. The plant will be producing metal racking systems for shelving, warehouse storage and other uses. The investment will bring dollars being spent outside of the US here to Sullivan County in the form of investment, jobs and a permanent ratable. We have assisted the company in a request for Empire State Development incentives. Onging.

d. Shovel Ready Sites

 A request has been made as we assemble needed funding for the 1st step of the Old Route 17 corridor analysis.

- SUNY Sullivan will be hosting an information session by NYESD on January 25, from 10AM-12PM covering new changes to the Start Up NY program which will make it more user friendly. It will take place at the Seelig Theater.
- e. Membership Education —At this time the date will be for this educational conference will be March 15, 2017. Look for update communiqués over the next several months. This year's conference will look to review more in depth development issues regarding the process and specific mandated reviews. Continuing education credits will be sought after for municipal professionals, as well as engineers and planners.

Plans for next year include highlighting Fly Fishing and the anniversary of Dirty Dancing.

- NYSTIA and Brand USA: A combined effort culminated in a CFA grant to assist NYS tourism entities to market through Brand USA to an expanded international market.
