ACTIVITY REPORT -MARCH 2017

COUNTY OF SULLIVAN INDUSTRIAL DEVELOPMENT AGENCY, SULLIVAN COUNTY FUNDING CORPORATION, THE SULLIVAN COUNTY INFRASTRUCTURE LOCAL DEVELOPMENT CORPORATION

March 31, 2017

At its regular meeting on March 13, 2017, the IDA Board approved several resolutions:

- Approving the regular quarterly payment to the Sullivan County Partnership for Economic Development.
- Extending the sales tax exemption period for the Veria Wellness Center Project, in accordance with the IDA's agreements with Veria Lifestyle Inc.
- Amending a 2013 resolution relating to the EPR Concord II, LLC Water Park Resort Project, reflecting changes to the project since the time of the original resolution.
- Appointing NY Delaware I, LLC as Agent of the IDA, and authorizing the execution of a
 Payment in Lieu of Tax Agreement, Lease Agreement, and related documents with this
 company. NY Delaware I, LLC proposes to develop a small-scale commercial solar facility
 in the Town of Delaware. This is the first project approved under the IDA's new
 Community Distributed Generation Uniform Tax Exemption Policy.
- Adopting a Language Access Plan in accordance with requirements of federal funding agencies.
- Authorizing an application to the US Department of Agriculture for grant funding to support outreach and marketing for the food hub project. This grant application was submitted on March 27.

Also on March 13, the IDA Board conducted its annual review and approval of its Mission Statement and Performance Measurements, in accordance with the New York State Public Authorities Law.

Throughout the month of March, IDA staff continued to collect PILOT payments from the Agency's projects and distribute those payments to the taxing jurisdictions. Staff also continued to prepare the IDA's annual reports for the New York State Public Authorities Reporting Information System (PARIS). Staff also assisted the IDA's auditors, who were on site during March to conduct field work related to their annual audit.

The Sullivan County Funding Corporation (SCFC) and The Sullivan County Infrastructure Local Development Corporation (TSCILDC) held special meetings on March 13, to review and approve their Mission Statements and Performance Measurements, as required by the Public Authorities Law. Like the IDA, SCFC and TSCILDC must also submit annual reports to PARIS. Staff is working to complete and file these reports.

SCFC continues work to assist local businesses through its grant application cost sharing program. We expect to receive more requests for assistance in the coming weeks and months as various federal and state funding opportunities are announced.

With respect to TSCILDC, staff continues its administration work as progress continues on the development of infrastructure for the Adelaar project, funded by public infrastructure bonds.

Report to Legislature – April 2017

A. General Operations

• The general economic outlook continues to be bullish on Sullivan County. Despite the Times Herald Record's continuation of focusing heavily on negative news when it comes to Sullivan County, there are significant indicators that directly speak to the beginning of Sullivan County's economic resurgence. That is newsworthy. For example:

For the 12-month period ending in January 2017, private sector job growth was fastest in Sullivan County (3.2 percent), followed by the Kingston MSA (+3.1 percent), and the Orange-Rockland-Westchester labor market area (+1.4 percent), according to the NYS Department of Labor; Non-farming jobs+2.8% (4th highest in NYS*).

This should have been front page material given how long we have been at the bottom of these indices, typically. In addition SmartAsset™, a financial technology modeling company (which studies economic indicators using powerful computer modeling tools to help companies and consumers make sound financial decisions), found that Sullivan County ranked 7th best place to buy a home in all of New York State; Again newsworthy. Along with a steady drop in unemployment rate year to year the economic outlook is healthy, given that no signature projects have come online yet, there are large municipal projects underway, and many other projects are slated to break ground soon.

As you know we have been discussing the development of shovel ready sites it seems like for decades. I have asked The Town of Liberty, Village of Liberty and Town of Thompson for funds to help pay for a corridor analysis of the area between exit 101 in Liberty and 102 in Thompson. I have also met with the County Manager and Chairman of the CED in to request the bulk of the funding for this analysis. The area is zoned IC and we have initially identified over 400 acres of available land suitable for industrial commercial development. The effort will involve a comprehensive analysis of land, cost of completing a GEIS for the corridor, cost of providing infrastructure, transportation, assessment of total build out capability, assessment of total potential investment and jobs that the corridor can sustain among many other market and environmental factors. This analysis is needed as the foundation to secure the necessary funding, for engineering, preapprovals and infrastructure needed to bring this area to shovel ready status. Our competitors within in the region and beyond continue to double down on these types of investments and have had a long track record of success because of it. We must take these necessary steps in order to create the product needed to compete in the market place and capitalize on the current momentum that has thus far been created. Moreover, not everyone looking for work here will be interested or is suited to work in the hospitality industry. We must create diverse job opportunities for those with certain skill sets that can be useful in other industry sectors. This result of this effort will introduce net new tax ratables, jobs and positive economic impacts that will help accelerate and continue the growth of our economy. Finally, with all of the discussion on the County's health statistics it is my opinion that not enough is being focused on the economic health of our residents and the prospects of their financial future. A steady job, at a reasonable wage will immediately begin to move the health care needle to the positive when resident can better afford healthier food choices and health care alternatives.

- The Partnership has joined a coalition made up of the Orange County Partnership, The Orange County Citizens foundation and private sector stakeholders to help advance an effort to improve traffic along route 17 from Harriman to the heart of Sullivan County. A NYSDOT study conducted in 2013 identified specific thresholds along the corridor based on traffic, development and other factors that would warrant improvements by the year 2020. Since then, there have been new developments already completed along the corridor, not covered in the study that has accelerated the time table of identified thresholds. In an effort to move improvements along the coalition has asked the state to fund the environmental review work needed to conduct any capital project geared to make necessary improvements along the thoroughfare.
- The specialty beverage fulfillment center mentioned at last meeting is beginning to move forward. After touring the county showing a variety of potential sites the firm's principal will be returning with his team in March to conduct their due diligence one of the sites previously shown. The project would include the development of a state of the art 250,000sq.ft facility and 50 jobs. The project is estimated at approximately \$10 million total investment. The principals of the firm have informed me that they will be selecting a site within the next week and will be putting remaining financing for the project together.
- We are working to attract a large fulfillment center for an internationally known retailer.
 The site selection includes many in areas throughout the northeast. However, we do have
 a location that may be a suitable fit. The project would introduce a significant tax ratable
 and several hundred jobs to the county. Developing.

B. Project Updates

a. Corporate Attraction

 We have shown four sites in response to an inquiry requiring 250,000sq.fr of fulfillment space. The project cost is approximately \$10 million with a demand for 50 jobs to start. Several sites were viewed favorably. However, we are competing with Orange County, NJ and PA at this time. Update: the principals are considering two Sullivan County sites at this time. A decision should be eminent.

c. Business Expansion

- We have met with the principals of We Ship Express 24/7. They will be looking to expand their operations significantly. We have been asked to provide an analysis of expanding at their current location and other locations that could increase their foot print from 33,000 sq. ft. to 100,000. Proportionate increase in employment would of course follow. The company has requested sample illustrations in order to make a prudent business decision. Ongoing.
- A local manufacturer will be investing in a new plant on a former food processing site. The plant will be producing metal racking systems for shelving, warehouse storage and other uses. The investment will bring dollars being spent outside of the US here to Sullivan County in the form of investment, jobs and a permanent ratable. We have assisted the company in a request for Empire State Development incentives. There has been substantial activity at the location thus far. Update: the project is moving forward steadily.

d. Shovel Ready Sites

- SUNY Sullivan will be rescheduling an information session by NYESD covering new changes to the Start Up NY program which will make it more user friendly. It will take place at the Seelig Theater on April 13, 2017.
- **e. Membership Education** —the next event will be held at the Catskill Distillery in May.

Our PR efforts are focusing on Fly Fishing and the 30th Anniversary of Dirty Dancing. SCVA is also hosting the editor of Family Fun magazine this summer for a fun fishing vacation and other family fun activities. SCVA is working with its members to create a Sullivan Catskill food experience and a showcase of the products produced here.

- > SULLIVAN CATSKILL PROUD: SCVA and its partners are working with Bold Gold Media to promote our local businesses and events.
- MARKETING PLAN: SCVA continues meeting with media outlets in business and leisure markets as well as individual niche markets for 2017 placements. At the same time the Association has been growing its digital and social reach.

- The Sullivan County Job Fair was held March 29 at the Ted Stroeble Center from 10:00 am 2:00 pm. There were 40 businesses with over 500 job openings along with workforce partner agencies BOCES, SUNY Sullivan, ACCES-VR, and Veterans talking to just over 300 job seekers. Immediate feedback from businesses was very positive. We will, as always, follow up with them in a couple of weeks to see how many hires came from the event.
- Planning has begun for the Summer Youth Employment Program that will provide 6 weeks of paid work experience to roughly 80 Sullivan County youth. The work experience opportunities take place in July and August.
- Planning for the Sullivan Renaissance Youth Internship program is underway. This program provides 18 youth with paid internships working with communities on Renaissance projects. The program runs from May through August.
- Work continues on implementation of new legislation, Workforce Innovation and Opportunities Act (WIOA). Policies and structural changes are under development. Work is being done currently on the creation of a One Stop Operator and a Memorandum of Understanding (MOU) between the Workforce Development Board and the workforce system partners.
