- ✓ For the local workforce system the Workforce Innovation and Opportunity Act requires a Memorandum of Understanding (MOU) between the required system partners. A draft MOU has been completed and is at the NYSDOL for review. The MOU outlines in general terms how agencies will work together to provide comprehensive services to our customers.
- ✓ Work has begun on the four year WIOA Local Plan for our workforce development area. It provides a snapshot of the area, an overview of the system and plans for how partners will deliver services. Where the MOU is the agreement to

partner, the Local Plan is the "how" we will partner. It is due to NYSDOL by the end of November but must be completed by October 31 to meet the 30 day public notice requirement.

#### ✓ NYSDOL Sector Partnership Grant Update:

- ✓ Deliverables include a career pathway template and the forming of the HV Catskills Regional Hospitality Skills Alliance.
- ✓ Grant was extended through June 2018.
- ✓ A regional forum was held in May and a "wrap up" meeting was held in June.
- ✓ The template is under development.
- ✓ In response to employer feedback a Career Readiness training and a Hospitality Orientation to the industry are being developed.
- ✓ Meetings with businesses will occur in September to receive feedback on products.
- ✓ Formalizing the structure of the Alliance will be a focus in September/October.
- ✓ A regional meeting will be scheduled in October to bring everyone back together to share updates, products and next steps.

# ACTIVITY REPORT -SEPTEMBER 2017 COUNTY OF SULLIVAN INDUSTRIAL DEVELOPMENT AGENCY, SULLIVAN COUNTY FUNDING CORPORATION, THE SULLIVAN COUNTY INFRASTRUCTURE LOCAL DEVELOPMENT CORPORATION

September 28, 2017

At its regular monthly meeting in September, the County of Sullivan IDA Board approved extensions of the sales tax exemption periods for three ongoing projects: Veria Lifestyle Inc.; Be Neet LLC and Jeff Sanitation Inc.; and HUDSUT LLC and HVFG LLC. The extensions will facilitate the continued construction and development of these three projects, in accordance with their agreements with the IDA.

In September the IDA received formal notification from USDA- Rural Development that we have been awarded two Rural Business Development Grants for fiscal year 2017. The IDA will use the grant funds to purchase equipment that will be leased to Catskill Brewery in Livingston Manor and Goodness Grainless in Narrowsburg. Agency staff and USDA representatives have met with both businesses to discuss their projects and the administration of the grants. We expect to complete both projects and close out both grants by late 2018.

The Sullivan County Infrastructure Local Development Corporation (TSCILDC) Board of Directors also met in September. At their meeting the Board approved the Special Assessment Report for the 2018 fiscal year, prepared by MuniCap, Inc., the administrator for the Adelaar infrastructure bonds. The infrastructure improvements related to the Adelaar development will be paid for by special assessments collected from the benefitted parcels. For the 2018 bond year, no special assessments are due.

During September staff prepared draft budgets for all three agencies (IDA, SCFC, and TSCILDC). In accordance with New York State Law, all public authorities must approve their 2018 budgets and submit them to the Authorities Budget Office by November 1, 2017.

As municipalities develop their 2018 budgets and tax caps, IDA staff members continue to provide information and assistance related to 2018 estimated payments in lieu of tax from IDA projects.

Late in September the IDA's offices were moved to a different location within the CVI Building, and this has been a major focus of staff time and effort.
