The meeting began at 7:05 pm with a salute to the flag of the United States of America.

Report of retired DEC Officer: Carl Lindsley In regard to the ice fishing on Feb. 12, 2022, Carl states the ice is good, the Boy Scout trailer for food and beverages is being set today, and hopefully a portable potty will be delivered today, as well.

A land survey was also in process, during his visit to the Boy Scout camp and they should retain property where existing camps are at Crystal Lake, and the balance is to be sold off, to settle lawsuits.

Two raffles will be forthcoming; one for a chainsaw donated by N. G. Gilbert Tree Service and one for a power plant (battery operated portable work light) donated by NYSEG. Carl Lindsley brought both of them to the meeting, and Gary Muthig provided him with leftover raffle tickets. Tickets for \$5.00 each are available from Carl Lindsley, or at the monthly meetings, and the drawing for each, will be at the April 2022 meeting. The proceeds from both will be used for the 2023 Youth Ice Fishing contest.

**Report of retired DEC Officer: Deming Lindsley** spoke about the union proposing a 20 year retirement vs. 25 year, which got vetoed for ECO officers. The end result was that retirement stays at 25 years.

A motion was made to dispense with the reading of the January 2022 minutes, since all clubs receive copies. Seconded and CARRIED.

#### **BILLS AND COMMUNICATIONS:**

Treasurer, Linda Loughrey presented the monthly bills. Expenses were mostly for ice fishing and coyote hunt, which were pre-approved. DEC for summer camp invoice for up to \$3,100.00 from Keith Krauss. Copier from Kristt \$449.00, pre-approved in January, being used at Marlene Dauch, Secretary's house. Motion made to pay bills, seconded and CARRIED.

Marlene Dauch briefly read the New York Echinococcus Surveillance Project, detailing sample collection by the 3 women attending the 2022 Coyote Contest, representing SUNY-ESF in Syracuse, NY. Corinne Conlon led and assisted in collecting 40 gastrointestinal tracts for samples to be screened. "The goal of the study is to understand the distribution and prevalence of Echinococcus spp. parasités in wild coyote populations in Northern New York State."

John Van Etten reported on National Geographic freelancers Rene Ebersole, a journalist, and Karine Aigner, a photographer, that attended the Coyote Hunt and dinner. The women sent an e-mail of thanks and appreciation for being able to attend the weigh in, attending the hunt with Tim Kautz of Jeffersonville, in his blind; talking with some of the volunteers and hunters, as well as to learn an inside perspective of what the hunt was all about. This could lead to an article and photos either on-line or in the magazine.

**Big Game: John Van Etten** Gary Muthig states COVID in deer on Staten Island, NY as reported in the Outdoor News.

**Bow Hunting: Ray Otto** absent. Harry Walker says they started a winter league on Monday nights at Travis Archery.

Silver Birch Archery is quite a nice archery shop and they do quite a lot for kids.

A new archery store, Catskill Outdoorsman, just opened up in Jeffersonville, NY, too. according to Gary Muthig.

Carl Lindsley has prizes, Erik Akerley bringing firewood and pallets, for bonfire; Hank Samyn picking up the bait, Ray Otto and Todd Buley will be drilling holes in the ice and Gary Muthig has the food and beverages. Eric Akerley, Issac Wertzberger and Mike O'Neill will be doing the length and weigh-ins. Fred Bosch will be handling registration. Carl Lindsley projected at least 125 kids for the contest. <u>UNFINISHED OR OLD BUSINESS:</u> Todd Brown from Grahamsville Rod & Gun Club sent a 4 page report regarding lead ammunition and effects on the environment. Eric Akerley from Denman Mountain Rod & Gun Club and Grahamsville Rod & Gun Club summarized the report, as Todd couldn't attend and present the information. Todd wanted to know the Federation's stance on the DEC wanting to outlaw lead ammunition and replace it with copper. Carl and Deming Lindsley both spoke on it, encouraging people

to fight this possible change. John Van Etten says he can do an e-mail to see what the member clubs have to say so we, as the Federation, can have a stance.

Bill Gates reminded everyone, again, if you have a New York State pistol permit, go on the NYS police website to renew. They are now only good for 5 years. There is no fee, but you can check to see if you need to renew and/or renew at the same time.

NEW BUSINESS: Eric Akerley encourages clubs and members to sign up for more events, rather than just the same 17 or 18 delegates (sign in sheet from tonight's meeting is attached) to volunteer and/or participate. He brought 3 men with him this time; Jarod Proyect from Woods Pond; Issac Wertzberger from Mishpocha; and Matt O'Neil from Denman Mountain Hunting & Fishing Club.

The local Turkey Federation sponsors turkeys for Thanksgiving, according to Gary Muthig. He recommends the Federation follow suit for Christmas, but for different recipients.
