For campfires burn only local firewood, less than 3' high and less than 4' wide. As always, when leaving, you should ALWAYS extinguish the burn site/pit using water and/or dirt.

Several people have asked about highway shooting. Deming says according to current laws, you cannot shoot across the highway. Anything maintained by a municipality counts as the highway, including median and shoulder. You do not have to be 50 feet away from the road, however, to hunt.


— 1st Annual — YOUTH FISHING CONTEST
