Emergency Meeting Sullivan County Legislature February 25, 2011 at 4:30PM

The Emergency Meeting of the County Legislature was called to order by Chairman Rouis at 4:35PM with the Pledge of Allegiance. It should be noted that six (6) legislators are present, two (2) legislators by telephone. We don't have anything specific in our Rules relating to calling in but we certainly wanted to make it available since this was an emergency meeting.

Roll Call indicated Mr. Armstrong absent.

The Clerk read the notice of meeting which read as follows:

There will be an Emergency Meeting of the Sullivan County Legislature on **Friday, February 25, 2011, at 4:30 PM** in the Legislative Committee Room of the County Government Center, Monticello, N.Y. The purpose of the meeting is to take action on resolutions to (1) ratify an Agreement with the Division of Public Works Supervisory Unit Teamsters Local 445, International Brotherhood of Teamsters; (2) to restore an abolished position; (3) to Modify the County Budget; and any other matter at the call of the Chairman.

Manager Fanslau stated that members of this union will contributed 15% of their health insurance in 2011 and 15% in 2012 with a yearly cap of \$2700. There will be no change in the longevity payments in 2011 and 2012, 2011 and 2012 infrastructure payments will be eliminated. Salary increase for 2011 will be 2 percent rather than 4 percent and the salary increase for 2012 will be 2.25% rather than 4.5%. They will remain as 13 full time positions till the end of the current CBA. In the event a vacancy occurs due to retirement, such vacant position may be removed through attrition.

Chairman Rouis wanted to thank Mrs. Shaddock and the membership of the Supervisory Group who got together and came up with a good agreement that answered a lot of the questions as DPW really needs to stay out there on the road. He commends everyone involved. Sometimes these things come down to the last minute and he is glad that it was ratified. It wasn't done without a lot of good back and forth and they worked together which really shows when everyone gets together, good things come out of it.

RESOLUTION NO. NO. 132-11 INTRODUCED BY JONATHAN F ROUIS, CHAIRMAN OF THE LEGISLATURE TO RATIFY A SIDE AGREEMENT WITH THE DIVISION OF PUBLIC WORKS SUPERVISORY UNIT TEAMSTERS LOCAL 445, INTERNATIONAL BROTHERHOOD OF TEAMSTERS, AND TO AUTHORIZE THE COUNTY MANAGER TO EXECUTE SAID AGREEMENT

WHEREAS, the County Legislature had authorized the County Manager to negotiate a side agreement with the Division of Public Works Supervisory Unit Teamsters Local 445, International Brotherhood of Teamsters to avoid costs to the County, and to restore an abolished position; and

WHEREAS, the County Manager has reached a Tentative Agreement with the Division of Public Works Supervisory Unit Teamsters Local 445, International Brotherhood of Teamsters, attached hereto as Schedule "A"; and

WHEREAS, the Division of Public Works Supervisory Unit Teamsters Local 445, International Brotherhood of Teamsters membership has approved the Tentative Agreement that is attached hereto as Schedule "A"; and

WHEREAS, it is in the best interest of the County for the County Legislature to ratify the Tentative Agreement that is attached hereto as Schedule "A".

NOW, THEREFORE, BE IT RESOLVED by the Sullivan County Legislature that:

- 1. The Tentative Agreement between the County and the Division of Public Works Supervisory Unit Teamsters Local 445, International Brotherhood of Teamsters, attached hereto as Schedule "A", is hereby ratified.
- 2. The County Manager is hereby authorized to execute the side agreement with the Division of Public Works Supervisory Unit Teamsters Local 445, International Brotherhood of Teamsters, in a form approved by the County Attorney and the Special Counsel for Labor.

Moved by Mrs. LaBuda, seconded by Mr. Sorensen, put to a vote with Mr. Armstrong absent, unanimously carried and declared duly adopted on motion February 25, 2011.

<u>Tentative Agreement for a Side Agreement with Division of Public Works</u> <u>Supervisory Unit Teamsters Local 445, International Brotherhood of Teamsters and</u> <u>Sullivan County 2/25/2011</u>

WHEREAS, the County Manager and authorized representatives of the Division of Public Works Supervisory Unit Teamsters Local 445, International Brotherhood of Teamsters (the "DPW Supervisor Unit") have agreed to a side agreement as follows:

- 1.) The bargaining unit employees will each contribute 15% of the Health Insurance Premium in 2011 and 15% in 2012 with a yearly cap of \$2,700, regardless of their respective date of hire.
- 2.) There will be no change to the current 2011 and 2012 longevity payments; they will remain as set forth in the current CBA.
- 3.) The 2011 and 2012 Infrastructure payments (payable in January, 2012 and January, 2013, respectively) will be eliminated.
- 4.) The salary increase for 2011 will be 2%, rather than 4%, effective as of the date of this Agreement, and the salary increase for 2012 will be 2.25%, rather than the 4.5% contained in the CBA.
- 5.) The staffing level for the DPW Supervisory Unit will remain at 13 filled full-time positions, through the end of the current CBA. In the event of a vacancy due to retirement, the title for such vacant position may be removed through attrition, at the discretion of the County.

This side agreement will not impact the current language regarding retiree healthcare, Article XI, Section C. All other terms and conditions of the original agreement will remain in effect.

NOW, THEREFORE, the above has been authorized by the DPW Supervisory Unit membership and is subject to ratification by the Sullivan County Legislature.
