RESOLUTION NO. 01-12 INTRODUCED BY THE COUNTY LEGISLATURE TO ADOPT THE RULES OF THE COUNTY LEGISLATURE

WHEREAS, pursuant to Section 153 of the County Law, the Sullivan County Legislature and its committees shall conduct their meetings in accordance with the Rules of the Legislature, and

WHEREAS, these Rules shall be interpreted by the Executive Committee, with amendments and additional rules to be adopted in accordance with the provisions of Rule 65 after consideration by said committee, and

WHEREAS, in absence of a rule or order not covered by these Rules, Robert's Rules of Order shall govern.

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature hereby adopts the Rules of the Legislature.

Moved by Ms. Vetter, seconded by Mr. Benson, put to a vote and unanimously carried and declared duly adopted on motion January 11, 2012.

RESOLUTION NO. 02-12 INTRODUCED BY THE COUNTY LEGISLATURE TO APPOINT THE COUNTY ATTORNEY

WHEREAS, in accordance with Section 4.00 of the Charter, there shall be a Department of Law, headed by the County Attorney, appointed by the County Legislature, and

WHEREAS, the term of office of the County Attorney shall be that term for which the then members of the appointing County Legislature were elected.

NOW, THEREFORE, BE IT RESOLVED, that Samuel S. Yasgur be and he hereby is appointed to the position of County Attorney.

RESOLUTION NO. 3-12 INTRODUCED BY THE COUNTY LEGISLATURE TO APPOINT THE CLERK TO THE COUNTY LEGISLATURE

RESOLUTION NO. 4-12 INTRODUCED BY THE COUNTY LEGISLATURE TO APPOINT THE DIRECTOR OF VETERANS SERVICE AGENCY

WHEREAS, in accordance to Section A5-6 of the Administrative Code of the Sullivan County Code, the Director of the Veterans Services Agency shall be a veteran and shall be appointed by and may be removed at the pleasure of the Chairman of the Legislature with the approval of the Legislature.

NOW, **THEREFORE**, **BE IT RESOLVED**, that John Crotty be and he hereby is appointed to the position of Director of Veterans Service Agency.

RESOLUTION NO. 5-12 INTRODUCED BY SCOTT SAMUELSON, CHAIRMAN OF THE LEGISLATURE REQUESTING NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION TO WITHDRAW THE SEPTEMBER 2011 REVISED DRAFT "SGEIS" ON THE OIL, GAS AND SOLUTION MINING REGULATORY PROGRAM, COVERING HORIZONTAL DRILLING AND HIGH-VOLUME HYDRAULIC FRACTURING IN THE MARCELLUS SHALE AND OTHER LOW-PERMAIBILITY GAS RESERVOIRS

WHEREAS, a large portion of the land area in the County of Sullivan is located within the Marcellus Shale Field Basin and therefore may be the location of natural gas exploration and development projects; and

WHEREAS, the County of Sullivan and several of its constituent municipalities have in the past voiced concerns to the New York State Department of Environmental Conservation (DEC) and to the New York State Legislature regarding issues of environmental safety and potential impacts resulting from natural gas development and related activities within the County, including, for example, noise, dust, integrity of nearby water wells, and the possibility of contamination resulting from storage and transport of fracking fluids; and

WHEREAS, DEC Division of Mineral Resources issued a Revised Draft Supplemental Generic Environmental Impact Statement (the "RD-SGEIS") on the Oil, Gas and Solution Mining Regulatory Program (the "Regulatory Program") dated September 7, 2011; and

WHEREAS, the County intends to submit substantive comments to the DEC by the deadline of January 11, 2012, citing concerns about the RD-SGEIS and the proposed Regulatory Program with regard to the following categories of concern:

- Municipal infrastructure, in particular protecting County and Town/Village roads;
- Coordination between DEC Mineral Resources and municipalities on permitting;
- Protection of groundwater aquifers from contamination by natural gas development;
- Impacts from natural gas development in flood-prone areas;
- Handling, storage and transport of toxic materials related to natural gas development;
- Cumulative impacts from pipelines, compressors and ancillary construction;
- Health of surface-water bodies, natural ecosystems and agricultural lands;
- Overall socioeconomic impacts on communities and existing economic sectors;
- Public health impacts;

NOW, THEREFORE, BE IT RESOLVED that, given the scope of additional research, documentation and analysis that is needed to address the aforementioned concerns and other legitimate concerns raised by members of the public, and to conduct a complete assessment of the potential environmental impacts from the proposed development, it is the County's view that the proceeding towards a Final SGEIS at this time would be inappropriate; and

BE IT FURTHER RESOLVED that the County of Sullivan hereby requests that the current RD-SGEIS be withdrawn, revised and reissued for full public review and comment, in the spirit of New York State Environmental Quality Review (SEQR), prior to proceeding with a Final SGEIS.

Moved by Mrs. Geiger, seconded by Mr. Steingart, put to a vote and unanimously carried and declared duly adopted on motion January 11, 2012.

RESOLUTION NO. 6-12 INTRODUCED BY SCOTT SAMUELSON, CHAIRMAN OF THE

LEGISLATURE, AUTHORIZING LUIZ C. ARAGON, COMMISSIONER OF PLANNING AND ENVIRONMENTAL MANAGEMENT, TO SUBMIT COMMENTS TO THE NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION (DEC) ON BEHALF OF THE COUNTY REGARDING THE REVISED DRAFT "SGEIS" ON THE OIL, GAS AND SOLUTION MINING REGULATORY PROGRAM, COVERING HORIZONTAL DRILLING AND HIGH-VOLUME HYDRAULIC FRACTURING IN THE MARCELLUS SHALE AND OTHER LOW-PERMAIBILITY GAS RESERVOIRS

- Coordination between DEC Mineral Resources and municipalities on permitting;
- Protection of groundwater aquifers from contamination by natural gas development;
- Impacts from natural gas development in flood-prone areas;
- Handling, storage and transport of toxic materials related to natural gas development;
- Cumulative impacts from pipelines, compressors and ancillary construction;
- Health of surface-water bodies, natural ecosystems and agricultural lands;
- Overall socioeconomic impacts on communities and existing economic sectors;
- Public health impacts;

NOW, THEREFORE, BE IT RESOLVED that the Commissioner of Planning and Environmental Management, Luiz C. Aragon, is hereby authorized to execute a letter to the DEC presenting comments and recommendations on behalf of the County.

Moved by Mrs. Geiger, seconded by Mrs. Edwards, put to a vote and unanimously carried and declared duly adopted on motion January 11, 2012.

Chairman Samuelson stated he has no specific comments but once again thanked everyone for their support.

Mrs. LaBuda stated it is a very exciting year for her. If you look around this room we have some new businessmen that will be a part of this body. She knows good things are going to happen and she wanted to say good luck to all of you.

Ms. Vetter thanked everyone for their support and feels there will be a great "moving forward" of Sullivan County.

Mr. Rouis echoed Mrs. LaBuda's comments. He thinks it is going to be a good year as we have a lot of challenges.

Mrs. Gieger stated she wanted to thank everyone for their support and she is looking forward to working with everyone. There are a lot of challenges and she would like to challenge everyone to get involved in your communities and attend your town board meetings. She wants to rebuild our community.

Mrs. Edward thanked everyone for their participation. We are a democracy and it is very important that we need to participate, maybe in ways that we never thought we would and she really feels that we will be as

good as the level of citizen participation in our local democracy. Everyone can meet us at almost anytime.

Mr. Benson thanked everyone for their support and for being here today. It just shows that everyone is willing to get involved. The election is over now regardless of party affiliation. We all have to work together to make the county a better place for all of us to live in.

Mr. Steingart stated it is exciting times. It is a change for him being in business for over 30 years. It is great to see that every legislator has Sullivan County in their heart and they are here to improve Sullivan County and is looking forward to working with everyone of them.
