RESOLUTION NO. 443-16 INTRODUCED BY AGRICULTURE AND SUSTAINABILITY POLICY COMMITTEE RESOLUTION TO ENACT A LOCAL LAW TO ESTABLISH A SUSTAINABLE ENERGY LOAN PROGRAM IN THE COUNTY OF SULLIVAN

WHEREAS, proposed Local Law to establish a sustainable energy loan program in the County of Sullivan was presented to the Sullivan County Legislature on October 5, 2016 at the County Government Center, Monticello, New York, to consider said proposed local law and notice of public hearing having been duly published and posted as required by law, and said public hearing having been held and all persons appearing at said public hearing deeming to be heard, and

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature does hereby enact and adopt this Local Law to establish a sustainable energy loan program in the County of Sullivan, State of New York, which local law is annexed hereto and made a part hereof.

LOCAL LAW NO. 3 of 2016

A LOCAL LAW TO ESTABLISH A SUSTAINABLE ENERGY LOAN PROGRAM IN THE COUNTY OF SULLIVAN

Be it enacted by the legislature of the County of Sullivan as follows: The Code of the County of Sullivan is hereby amended by adding a new Chapter, entitled "Energize NY Benefit Financing Program," to read as follows:

ARTICLE I

- §1. Legislative findings, intent and purpose, authority.
- A. It is the policy of both the County of Sullivan and the State of New York to achieve energy efficiency and renewable energy goals, reduce greenhouse gas emissions, mitigate the effect of global climate change, and advance a clean energy economy. The County of Sullivan legislature finds that it can fulfill this policy by providing property assessed clean energy financing to property owners for the installation of renewable energy systems and energy efficiency measures. This chapter establishes a program that will allow the Energy Improvement Corporation ("EIC"), a local development corporation, acting on behalf of the County of Sullivan, to make funds available to qualified property owners that will be repaid by such property owners through charges on the real properties benefited by such funds, thereby fulfilling the purposes of this chapter and fulfilling an important public purpose.
- B. The County of Sullivan is authorized to implement this Energize NY Benefit Financing Program pursuant to Article 5-L of the New York General Municipal Law.

§2. Title

This chapter shall be known and may be cited as the "Energize NY Benefit Financing Program Law of the County of Sullivan".

§3. Definitions

For purposes of this chapter, and unless otherwise expressly stated or unless the context requires, the following terms shall have the meanings indicated:

Authority – The New York State Energy Research and Development Authority, as defined by subdivision two of section eighteen hundred fifty-one of the public authorities law, or its successor.

EIC – The Energy Improvement Corporation, a local development corporation, duly organized under section fourteen hundred eleven of the Not-For-Profit Corporation Law, authorized hereby on behalf of the County of Sullivan to implement the Energize NY Benefit Financing Program by providing funds to Qualified Property Owners (as defined in this chapter) and providing for repayment of such funds from monies collected by the Sullivan County Treasurer, as tax collector as a charge to be levied on the real property and collected in the same manner and same form as the real property taxes.

Energy Audit – A formal evaluation or "assessment" of the energy consumption of a permanent building or structural improvement to real property, conducted by a contractor certified by the Authority, or certified by a certifying entity approved by the Authority, for the purpose of identifying appropriate energy efficiency improvements that could be made to the property.

Energy Efficiency Improvement – Any renovation or retrofitting of a building to reduce energy consumption, such as window and door replacement, lighting, caulking, weather-stripping, air sealing, insulation, and heating and cooling system upgrades, and similar improvements, determined to be cost-effective pursuant to criteria established by the Authority, not including lighting measures or household appliances that are not permanently fixed to real property.

Qualified Property Owner – An owner of residential or commercial real property located within the boundaries of the County of Sullivan that is determined to be eligible to participate in the Energize NY Benefit Financing Program under the procedures for eligibility set forth under this chapter.

Renewable Energy System – An energy generating system for the generation of electric or thermal energy, to be used primarily at such property, by means of solar thermal, solar photovoltaic, wind, geothermal, anaerobic digester gas-to-electricity systems, fuel cell technologies, or other renewable energy technology approved by the Authority not including the combustion or pyrolysis of solid waste.

Renewable Energy System Feasibility Study – A written study, conducted by a contractor certified by the Authority, or certified by a certifying entity approved by the Authority, for the purpose of determining the feasibility of installing a renewable energy system.

§4. Establishment of an Energize NY Benefit Financing Program

- A. An Energize NY Benefit Financing Program is hereby established by the County of Sullivan, whereby EIC acting on its behalf, may provide funds to Qualified Property Owners in accordance with the procedures set forth under this chapter, to finance the acquisition, construction and installation of Renewable Energy Systems and Energy Efficiency Improvements and the verification of the installation of such systems and improvements.
- B. The funds provided shall not exceed the lesser of ten percent of the appraised value of the real property where the Renewable Energy Systems and/or Energy Efficiency Improvements will be located, or the actual cost of installing the Renewable Energy Systems and/or Energy Efficiency Improvements, including the costs of necessary equipment, materials, and labor and the cost of verification of such systems and improvements.

§5. Procedures for eligibility

- A. Any property owner in the County of Sullivan may submit application to EIC on such forms as have been prepared by EIC and made available to property owners on the website of EIC and at the County Manager's offices.
- B. Every application submitted by a property owner shall be reviewed by EIC acting on behalf of the County of Sullivan, which shall make a positive or negative determination on such application based upon the criteria for making a financing enumerated in subsection A of Section 6 of this chapter. EIC may also request further information from the property owner where necessary to aid in its determination.
- C. If a positive determination on an application is made by EIC acting on behalf of the County of Sullivan, the property owner shall be deemed a Qualified Property Owner and shall be eligible to participate in the Energize NY Benefit Financing Program in accordance with the procedure set forth under Section 7 of this chapter; provided that in no case shall a property owner that has received funds from another municipal corporation for the acquisition, construction and installation of Energy Efficiency Improvements and/or Renewable Energy Systems be deemed a Qualified Property Owner.

§6. Application criteria

- A. Upon the submission of an application, EIC acting on behalf of the County of Sullivan, shall make a positive or negative determination on such application based upon the following criteria for the making of a financing:
 - 1. The proposed Energy Efficiency Improvements and/or Renewable Energy Systems are determined to be cost effective by the Authority;
 - 2. The proposed Energy Efficiency Improvements and/or Renewable Energy Systems will generate an estimated annual cost savings greater than the annual charge payments;
 - 3. Sufficient funds are available to provide to the property owner;
 - 4. The property owner is current in payments on any existing mortgage;
 - 5. The property owner is current in payments on any existing real property taxes and has been current on real property taxes for the previous three years; and
 - 6. Such additional criteria, not inconsistent with the criteria set forth above, as the County of Sullivan, or EIC acting on its behalf, may set from time to time.

§7. Opt-in, Energize Finance Agreement

A. A Qualified Property Owner may participate in the Energize NY Benefit Financing Program through the execution of an Energize Finance Agreement made by and between the Qualified Property Owner and EIC, acting on the behalf of the County of Sullivan.

- B. Upon execution of the Energize Finance Agreement, the Qualified Property Owner shall be eligible to receive funds from EIC acting on behalf of the County of Sullivan, for the acquisition, construction, and installation of qualifying Renewable Energy Systems and Energy Efficiency Improvements; provided the requirements of Section 8 of this chapter have been met.
- C. The Energize Finance Agreement shall include the terms and conditions of repayment set forth under Section 9 of this chapter.

§8. Energy audit, renewable energy system feasibility study

- A. No funds shall be made available for Energy Efficiency Improvements unless determined to be appropriate through an Energy Audit as defined in Section 3 of this chapter.
- B. No funds shall be made available for a Renewable Energy System unless determined to be feasible through a Renewable Energy System Feasibility Study as defined in Section 3 of this chapter.
- C. The cost of such Energy Audit and/or Renewable Energy System Feasibility Study shall be borne solely by the property owner but may be included in the financed amount if the work is approved.

§9. Terms and conditions of repayment

The Energize Finance Agreement between the Qualified Property Owner and EIC, acting on behalf of the County of Sullivan, shall set forth the terms and conditions of repayment in accordance with the following:

- A. The principal amount of the funds paid to the Qualified Property Owner hereunder, together with the interest thereon, shall be paid by the property owner as a charge on their real property tax bill and shall be levied and collected at the same time and in the same manner as real property taxes, provided that such charge shall be separately listed on the tax bill. The County of Sullivan, shall make payment to EIC or its designee in the amount of all such separately listed charges within 30 days of the County's tax due date.
- B. The term of such repayment shall be determined at the time the Energize Finance Agreement is executed by the property owner and EIC, provided that in no case shall the term exceed the weighted average of the useful life of the systems and improvements as determined by EIC acting on behalf of the County of Sullivan.
- C. The rate of interest for the charge shall be fixed by EIC acting on behalf of the County of Sullivan at the time the Energize Finance Agreement is executed by the property owner and EIC.
- D. The charge shall constitute a lien upon the real property benefited by the Energize NY Benefit Financing Program and shall run with the land. A transferee of title to the benefited real property shall be required to pay any future installments, including interest thereon.

§10. Verification and report

- A. EIC shall be responsible for verifying and reporting to the County of Sullivan on the installation and performance of Renewable Energy Systems and Energy Efficiency Improvements financed by such program.
- B. The County of Sullivan shall verify and report on the installation and performance of Renewable Energy Systems and Energy Efficiency Improvements financed by the Energize NY Benefit Financing Program in such form and manner as the Authority may establish.

§11. Effective Date

This local law shall take effect upon filing with the Secretary of State.

WHEREAS, Local Law 6 of 2012 provides that there shall be an annual Solid Waste Fee and that the County Legislature establish by resolution a "Rate Schedule assigned to all parcels of improved property based upon the authorized use of real property", and

WHEREAS, a proposed Rate Schedule has been submitted to the Legislature for adoption for calendar year 2017, and

WHEREAS, the County Legislature has determined that the proposed Rate Schedule will not create any significant adverse environmental impacts.

BE IT THEREFORE RESOLVED AS FOLLOWS:

- 1. For the calendar year 2017 the Solid Waste Fees shall be as follows:
 - A. The annual direct billed portion of the solid waste fee, billed to owners of parcels of improved property, shall be as follows:
 - i. Residential category = \$120.00 per parcel.
 - ii. Residence with enhanced STAR or Aged Exemption category = \$108.00 per parcel.
 - iii. Commercial Residential category = \$120.00 per unit, up to 15 units, then capped at \$1,800.00 per parcel.
 - iv. Legislative Definitions category = \$120.00 per parcel.
 - v. Commercial (non-residential) category = \$300.00 per parcel.

RESOLUTION NO. 470-16 INTRODUCED BY THE EXECUTIVE COMMITTEE TO AUTHORIZE FINANCIAL AND IN-KIND SUPPORT FOR THE SULLIVAN COUNTY LAND BANK CORPORATION

WHEREAS, RESOLUTION NO. 286-16 authorized the formation and incorporation of the Sullivan County Land Bank Corporation (SCLBC) expressly subject to the approval of the Empire State Development Corporation (ESD) and pursuant to §1603 of the Not-for-Profit Corporation Law; and

WHEREAS, an application to form the Sullivan County Land Bank Corporation was submitted to ESD and approval is expected on November 17, 2016; and

WHEREAS, RESOLUTION NO. 286-16 further authorized the expenditure of \$100,000.00 per year, for a maximum of two years, to fund the land bank upon its incorporation; and

WHEREAS, RESOLUTION NO. 286-16 named specific County officials and legislators to serve an initial two (2) year term on the SCLBC Board of Directors; and

WHEREAS, Local Initiatives Support Corporation and Enterprise Community Partners, Inc. have jointly issued a Request for Applications for funding under the NYS Land Bank Community Revitalization Initiative (CRI), with funds to come from national settlements reached among the New York State Office of the Attorney General, Federal regulators, and Morgan Stanley, and Goldman Sachs respectively; and

WHEREAS, applications for the CRI funding are due on November 30, 2016; and

WHEREAS, applications for the CRI funding require a letter of support from a County and/or municipal sponsor;

NOW, THEREFORE, BE IT RESOLVED, that the Sullivan County Legislature hereby authorizes the expenditure of funds and staff time required to incorporate the land bank and establish procedures and policies for its administration; and

BE IT FURTHER RESOLVED, that the Sullivan County Legislature hereby authorizes County staff to prepare an application for CRI funding for the planned Sullivan County Land Bank Corporation; and

BE IT FURTHER RESOLVED, that the Chairman of the Legislature is hereby authorized to sign the Cover Letter of Support for the Land Bank Funding Application required of the County and/or municipal sponsor; and

BE IT FURTHER RESOLVED, that the Sullivan County Legislature authorizes the County Manager to enter into an agreement with the Sullivan County Land Bank Corporation relative to the County funding approved in RESOLUTION NO. 286-16 referenced above, and to the provision of such in-kind staff services to the land bank as needed to support its ongoing development including, but not limited to, efforts to seek additional funding from grants and from financial or in kind services from participating municipalities and the private sector, the recruitment and oversight of project-specific consultants and/or land bank staff, the creation of a strategic plan, identification and acquisition of property, and the coordination of land bank activities with related efforts concerning code enforcement, zombie properties, and neighborhood revitalization.

Moved by Mr. Steingart,, seconded by Mrs. Ward, put to a vote unanimously carried and declared duly adopted on motion November 17, 2016.

There being no further business, Mr. Perrello moved to adjourn, seconded by Mrs. Owens subject to the call of the Chairman. The full board meeting was adjourned at 2:42PM.



Sullivan County Social Worker and Community Volunteer Honored for Outstanding Service

Social Worker and Community Volunteer Daniel Berkowicz to Receive Annual SYDA Foundation Community Service Award

South Fallsburg, NY October 19, 2016 – The SYDA Foundation today announced that Daniel Berkowicz of Loch Sheldrake, NY, has been selected as the recipient of the 2016 SYDA Foundation Community Service Award. The prestigious award includes a certificate of merit for outstanding service to the local community and a monetary gift of \$5,000.

The SYDA Foundation Community Service Award will be presented to Mr. Berkowicz on Thursday, November 17, at 2:00 p.m., at the monthly meeting of the Sullivan County Legislature, at the Government Center in Monticello. The public is warmly invited to attend the presentation.

Since 1986, the SYDA Foundation has sponsored this annual award—one of Sullivan County's highest distinctions—to recognize and honor local citizens for outstanding community service. A committee of past SYDA Foundation

Community Service Award recipients and local civic leaders selected Daniel Berkowicz to receive this year's award. Daniel was selected in recognition of his

years of service in support of the needs of intellectually and developmentally-challenged individuals and as a devoted community volunteer.

With a background in social work, Mr. Berkowicz came to Sullivan County in 1974 and soon after was asked to develop and lead a new residential program for people with intellectual and developmental disabilities on a soon-to-be-purchased 44-acre site of a former resort hotel. Daniel had a vision of creating a nurturing, caring alternative to large institutions, where people with medical, mental health, or developmental challenges could learn and experience living independently and with dignity. This vision grew into New Hope Community in Loch Sheldrake, now with over 40 different residential opportunities throughout Sullivan County, and recognized nationally as a leader in the field of human services. Over 35 years, Mr. Berkowicz served as Executive Director of New Hope Community and has contributed to the empowerment and well being of thousands of New Hope Community residents and their families.

In addition to his service as leader of New Hope Community, Daniel has volunteered for 37 years as a member of the Loch Sheldrake Fire Department (LSFD) and is presently the Loch Sheldrake Fire Police Captain. Mr. Berkowicz is also a publicly-elected member of the Board of Fire Commissioners and in this role he helps ensure that the LSFD has necessary resources for its fire and rescue activities that are so vital for the protection of life and property within the Loch Sheldrake Fire District.

After retiring from New Hope Community in 2010, Mr. Berkowicz sought other ways to serve the community and joined the Board of Hospice of Orange and Sullivan Counties. In addition to being a Board Member, Daniel is also a hospice volunteer and visits the homes of terminally ill patients to give aid and comfort to not only the patients, but to family members as well.

Daniel is passionate about soccer and is an advocate for children. He was a coach and referee for the Sullivan County Chapter of the American Youth Soccer Organization (AYSO) for many years.

Daniel met his wife, Linda, on a blind date at the Liberty Diner over 20 years ago and they have three sons, Jereme, Josh, and Noah, and a daughter, Jessica.

The SYDA Foundation, located in the Town of Fallsburg since 1979, is a not-for-profit organization that makes Siddha Yoga meditation available to students around the world. The SYDA Foundation contributes to the Sullivan County

community through regular monetary donations to the local volunteer fire departments, police, school district, and hospital, and through its philanthropic expression—PRASAD Children's Dental Health Program.
