

**Sullivan County Legislature  
Emergency Meeting  
December 18, 2017 at 1:15PM**

The Emergency Meeting of the County Legislature was called to order at 1:22PM by Chairman Alvarez with the Pledge of Allegiance.

Roll Call indicated Mr. Samuelson, Mr. McCarthy and Mrs. Owens absent.

The Clerk read the Emergency Meeting Notice:

There will be an Emergency Meeting of the Legislature **for Monday, December 18, 2017 at 1:15PM** in the Legislative Chambers, 100 North Street, Monticello, New York. The purpose of the meeting is to revise Resolution Nos. 503-17 and 504-17 by correcting the apportionment and equalization table adopted on December 14, 2017 and any other business that may come before the Legislature.

**RESOLUTION NO. 532-17 INTRODUCED BY LUIS A ALVAREZ, CHAIRMAN OF THE LEGISLATURE, JOSEPH PERRELLO, LEGISLATOR DISTRICT 7 AND IRA STEINGART LEGISLATOR DISTRICT 8 TO AMEND THE 2018 APPORTIONMENT AND EQUALIZATION TABLE**

**WHEREAS**, Resolution No. 503-17 adopted by the Sullivan County Legislature on December 14, 2017 had an attachment which detailed the Apportionment to be utilized among the towns for the 2018 County Tax; and

**WHEREAS**, Resolution No. 504-17 adopted by the Sullivan County Legislature on December 14, 2017 had an attachment which contained the Equalization Table to be utilized among the towns for the 2018 County Tax; and

**WHEREAS**, the County was recently informed that data supplied to the County by certain towns contained errors which require the County to alter the Apportionment and Equalization Table; and

**WHEREAS**, in order to address the necessary changes to the Apportionment and the Equalization Table new attachments have been drafted.

**NOW, THEREFORE, BE IT RESOLVED**, that the attachment to Resolution No. 503-17 which contained the Apportionment shall be removed and the corrected Apportionment, attached hereto as Exhibit A, shall be inserted in its place, and

**BE IT FURTHER RESOLVED**, that the attachment to Resolution No. 504-17 which contained the Equalization Table shall be removed and the corrected Equalization Table, attached hereto as Exhibit B, shall be inserted in its place.

**Moved by Mr. Perrello, seconded by Mrs. Rajszyk**, put to a vote with Mr. Samuelson, Mr. McCarthy and Mrs. Owens absent, unanimously carried and **declared duly adopted on motion** December 18, 2017.

There being no further business, Mrs. Ward moved to adjourn, seconded by Mr. Perrello, subject to the call of the Chairman. The Emergency meeting was adjourned at 1:23PM.
