



General Park Rules and Regulations

1. Entering or remaining upon any property or within any structure during such hours, seasonal or indefinite periods that such property or structure had been designated as closed by a sign or by any authorized person is prohibited.
2. Unless otherwise designated at certain parks or sections of parks by sign or written permit, all parks, recreational or historical sites under the jurisdiction of the County shall be open from dawn to dusk. Use before or after these times are unauthorized and not permitted.
3. No person shall disobey a lawful order of any officer or employee of the County or the directions of any sign erected by or at the direction of the County.
4. Disposing of any garbage, sewage, refuse, waste, paper or litter of any kind except in receptacles provided is prohibited.
5. Injuring or defacing any area, building, sign, equipment or other property found within the park is prohibited. No tree, flower or shrub is to be removed or destroyed.
6. Use of threatening, abusive or insulting language, performance of any obscene acts, fighting or assaulting another person is prohibited.
7. Any excessive noise created in any manner is prohibited.
8. No person having custody or control of a minor shall permit such minor to do any act in violation of a rule or regulation of the county.
9. Firearms and weapons. No person other than a member of a federal, State or municipal law enforcement agency, shall introduce or possess either upon the person or within a vehicle, or use any firearm or any instrument or weapon the propelling force of which is a spring, rubber or air or any ammunition or propellant therefore, or a bow and arrow, except as permitted by a rule or regulation of the County.
10. Hunting and/or the discharging of any firearm or weapon is prohibited unless specifically authorized in designated areas and only in a manner licensed by the State of New York.
11. Swimming is prohibited unless in designated areas, and only when County employed lifeguards are on duty.
12. Possession or use of an axe, machete or cutting tool other than a hatchet or sheath knife for the purpose of preparing wood for a cooking fire is prohibited.
13. Fires may be built and maintained only in fireplaces, grills or stoves suitable for cooking purposes. All fires must be under the supervision of a responsible person.
14. Alcoholic beverages are prohibited in all parks, unless a permit is obtained from the County (see Part 600.1 Section n).
15. Conducting of a business, selling or soliciting of any kind is prohibited unless a written permit is obtained from the County.
16. No person shall use or operate an all-terrain vehicle (ATV), or other similar wheeled vehicle or snowmobile on any park property or park roadway unless said property is signed and designated for this use.
17. Pets must be properly muzzled and restrained by a leash. Pets are prohibited in buildings, picnic areas, bathing areas and improved walkways. Pets must be cleaned up after.
18. All groups consisting of 25 or more must secure a group park permit.
19. All forms of smoking on county grounds is prohibited.
20. The use or operation of a metal detector or other mechanical device to locate buried or concealed metal is prohibited.
