### Training in the Trades

- Funded at \$100,000 for 2024 by the Sullivan County Legislature. 2024 an Automotive training was held, and CWD is currently recruiting for a NYS Certified Security Guard training to start December 2nd thru December 12<sup>th</sup> M-F 9 am to 6pm
- An RFP for training is on the November legislative approval to simplify the Trades programs to include Resolutions, Facilities Use Agreements, MOU's, and Contracts. This will cover things such as CNA, Construction, Welding, Automotive, Culinary, Electrical, etc., to be open ended, with focus on partner collaboration. Approvals to be in place by end of 2024 so in 2025 trainings can be scheduled.

### Workforce Innovation Opportunity Act (WIOA)

- $\circ$   $\;$  The full PY24 allocations has now been received, which resulted in an 11% reduction of WIO funding
- \$100,000 additional funding received from NYSDOL for Adult and Dislocated Worker training and supportive services. This is being focused on On-the-Job trainings for Sullivan County businesses and must be expended by 6/30/24
- An RFP for an "Outreach Strategic Plan" was awarded to Bold Gold Media. The Resolution was passed, Contracts are signed, and a meeting is scheduled for November 20<sup>th</sup> to start the campaign. This will be over a two-year period.
- WIOA Adult & Dislocated Workers
  - ✓ 51 participants
  - 1 in training; 3 pending OJT trainings; 5 pending CNA for 2025; others seeking employment, career exploration, certification, resumes, or supportive services
  - 21 of the participants are Trades recipients that have a mandatory 12 month follow through
- o WIOA Youth
  - ✓ 20 participants
  - ✓ 9 active enrollments
  - ✓ o in Work Experiences; 4 enrolled in GED classes; 4 unsubsidized employment; 1 pregnant & parenting
  - ✓ Continue to meet monthly with individuals being released from Jail
  - Attend MLK summit meetings; Care Pillar meetings, and Children's SPOA committee meetings
- o NYSCION
  - ✓ Round table & sustainability group monthly meetings are going well with additional businesses coming onboard
  - ✓ National Disability Employment awareness month Event was held @ The Government Center on 10/24/24 to bring awareness to Employers, Participants and the community
  - ✓ The DRC attended NY State Disability Rights Employment Awareness month symposium in Albany
  - ✓ As of October 2024, 178 NYSCION participants have been served by the DRC, 128 are enrolled in NYSCION, 5 active Tickets to Work, and 26 individuals with disabilities gained employment
  - ✓ The DRC sits on three SC Task Force pillars, SALT, SPOA, SC Treatment Court, National Navigator Exchange, and the NYS Coalition to prevent addiction and support recovery in employment. Meetings are held monthly
  - ✓ Neurodiversity training for CWD staff is being review and an RFP for training will be sent out

#### Temporary Assistance (TA)

- $\circ$  ~ SPCA joined forces with CWD and is now a TA worksite
- The final TA audit meeting was November 14<sup>th</sup> with OTDA. DSS & CWD are working on the responses that are due by December 27th
- For the month of October there were 7 entries to employment, and 7 individuals in a work experience
- The caseload for October 2024 was 405 with 198 employable cases
- Orientation is every Wednesday at CWD and meetings are held monthly between DSS & CWD. 110 participants were referred to orientation with only 53 attending. Since CWD doesn't have enough funding to keep four employees in TA, one of the employees has been
