Federation of Sportsmen's Clubs of Sullivan County, Inc., meeting of August II, 2010. The meeting began at 7:35 p.m. with a salute to the flag with 39 delegates present. A moment of silence was held in memory of Harold Puerschner, a long time valued member of the Cherokee Hunting Club. He will be missed. Guests: Lt. Deming Lindsley, DEC CO; Carl Lindsley, DEC Bear Specialist; Sondra Bauernfeind. Carl is extremely busy handling the bear situation, with 3 to 5 complaints daily. Hot spots include Fallsburg, Forestburg and Brisco. Warning letters are given out with 10 days notice and if garbage problems are not corrected then they go to court. Camp DeBruce had a very successful year holding camp 6 weeks instead of 8. Carl wished to thank the three Federation members who showed up to help him. He indicated that deer permits in 3H were drastically reduced. He is holding a trapping course 9/19 (see below) and requested quick sign-up since class will get filled quickly. A survey is being done in Region 3 concerning the tributaries of every stream entering the Delaware and Beaverkill rivers looking for water barriers which in the future may be cleared. Deming indicated lots of people getting tickets for fishing without a license. Burning brush is now permitted, but just brush. Logs must be no bigger than 8' in length and 6" in diameter. Sandra Bauernfeind introduced herself as a life member of the NRA and indicated that she has a pistol permit and that her home was recently broken into. She indicated that the law dictates that if she shot the intruder she would be arrested. She spoke about the 2010 New York "Castle Doctrine" campaign, supported by the NRA and the fact that many states are now enacting this new law to give homeowners the right to protect themselves against criminal attackers and asked that all our clubs write to their state and local legislators requesting their support of the Castle Doctrine Law. She is also requesting drug free zones in Sullivan County. Corrections to July 14 minutes: Can use up to 5 1/2 h.p. motors (minutes indicated not more than 5 1/2 gal. gas.) DEC not advocating 100% deer reporting prior to issuance of new license for current year but delegates from various counties requesting this. Motion to dispense with reading July minutes since all clubs receive copies. Seconded, CARRIED.

BILLS AND COMMUNICATIONS:

Motion to pay all bills. Seconded, CARRIED. Received 9 thank you letters from campers at the DEC camp and all were read indicating they really had a wonderful experience and learned lots of great stuff. Received a letter from Sunrise Farm Rod & Gun Club requesting payment of a youth fishing event already held. (See New Business). The county is now requesting copies of minutes of all organizations they help fund. Secretary will be sending this off to them when she sends out minutes to clubs. If for some reason you do not want your name or phone number in these minutes should you be working on something please advise her directly following the meetings and she will eliminate same on the copy going to the county. President indicated he had a barbecue for all those helping with the coyote contest which was enjoyed by all on a wonderful day. Our request for county assistance must be in by 8/15 and President already wrote a letter asking for \$25,000 so we can maintain our programs for the 2011 year. Complementary dinner banquet letters will be going out shortly for our 10/2 banquet at the Rockland House. Anyone wanting to solicit for door prizes please do so and the person who donates a prize will be recognized at this banquet. Grahamsville Fair is this coming weekend. Predator contest applications are ready and have been mailed to all contestants in our Annual Coyote Hunt. Tag numbers cost \$25. Pat Votes has done the mailing and wants to donate mailing costs of the Predator Contest to one of our youth programs. President will begin advertising the Predator Contest in about a month or so and applications were sent to all clubs and can be gotten oft the web site.

V.P.: Kaiser Equipment in Livingston Manor has donated a refrigerator for our Federation building. Secretary to send thank you letter. Elizabeth and Harris Myers have donated a microwave. Secretary to send thank you letter.
