- III. Acceptance of Minutes from January 6th minutes. Members asked to review for any changes. As per Connie: Under Treasurer's report: Allegany wanted \$10,000 for the trademark for Peer Worx. It can be renewed. 2 CD's can be renewed at 15 months at 2.13% and 1.09% on other. Would like to take \$5000.00 open another CD out of Money Market Savings Account. Would like to do it with Jeff Bank to begin doing business with another bank. Motions: 1: Change 2 CD's at Catskill: Leo moved, and it was seconded by Ann Milucky. 11 to 15 month. 2: Take more @ out of MM account. Moved Leo: to take 25,000 dollars. Leo rescinded to new amount of \$15,000 dollars into 2 CD's. Seconded: by Gary. Amend 15,000 into a CD, one and \$10,00 into another. Back to 25,000. Both would be for 15 months. Passed. Leo amended to accommodate that. C: We're going to be cut 12,000 and our resources are drying up. K: When that time comes, we can withdraw funds with very little or no penalty. A: There will be penalty but we'll be ahead of it. C: Feels \$10,000 should be amount and not \$25,000 Q: What do you have to lose? We have enough to cover and can always take money out. Comment: put money into 2 CD's to avoid large penalty. It would be for smaller term. Interest won't be as much. Q: Leo: Why do we need all of this in slush fund? We'd be cutting into interest rate. Motion to accept by Flynn/Seconded by Leo.

V. Smaller Fundraising Committee Reports:

- Personnel Committee Report: Committee met 1/21 Leo, Mary May and Barbara had to decide amount of money Director has been allowed per month. Received \$13,000 in salary. \$6,000.00 will be bonus-unearned income.
- 2. Tutor Trainers' Report: Training dates: 2/23, 25, 27. Have 6 people signed up so far. All trainers have been asked to attend.

We can possibly win \$3,000 for beautification of our Bethel Site. If we wanted to enter as Category B: we could do a project here and one at Bethel. Then you get \$1500 and a summer intern to work the project with you. We can do slight improvements here (trees between our lot and skateboard park). Can win \$10,000. We do meet the criteria for writing a grant. There are extra prizes too. Can we get sign close to the road? That's a town issue. Leo will follow up on that. Barbara Sush will head this up. All Board Members will be on committee. She will need everyone's help because one part of it is keeping a journal. Ken can take before and after pictures. Need a treasurer, etc. It will take more than just a couple of us. Grants awarded in March and prizes are awarded in the summer. Jaime Noeth will spearhead fundraisers with Barbara to supplement money we receive to participate. Probably a good portion of \$1500 will be spent at Bethel Site as we are just starting there. We will have to put together a preliminary budget. We will look at a packet next meeting. We will have time set aside for that at next meeting. VIII. Director's Report:

- Raised almost \$6000 from fundraising letters.
- Received monies from Monticello School District –Peer Worx.
- We were supposed to get 28,000, now down to 25,000 from state ed. We're hoping to prevent 40% cut to this amount in next year's state budget.
- In separate packet Student-Tutor Recognition Dinner concerns: We need space. It's becoming very labor intensive because of book shelves. Pick date in May. We can have fire dept for \$20 per hour. We give \$300.00 deposit. We have to clean up or lose deposit. Move: Leo to move into firehouse. Seconded by: everyone. Decided on: May 19th, 3rd Wednesday of May.

- We have a Student Recruitment Committee. Janet is chair. Asked her to: Please take look at goals. Please meet and think about making a plan to get to ESL teachers throughout county. So they can talk to parents of students, approach or make presentation at Head Start.
