- Jeff is reviewing the membership and fundraising lists to determine how the Board will proceed with the ASK campaign.

7. Programming Committee Report

- Maureen Neville has joined this committee and is a tremendous resource.
- Possible performers for the spring and fall are Red Molly, The Speckers and Livingston Taylor.
- We have also reached out to Adrianne Picciano and John Bachman for recommendations from the younger, tuned in members of our community. How to market this broad range of programming is always the challenge.
- Anne & Hester are actively working on the community needs assessment for the strategic plan, initially targeting sub groups of our members and non members (e.g., grant recipients, as well as those who were initially interested but chose not to apply for grants, business members, etc).
- Ideas for the proposed film festival were discussed.

8. Facilities Report

• The office was painted and the rest of the new furniture is in place. There have been some problems with the phones and the wiring needs to be cleaned up.

9. Director's Report

- Another contribution to the pillar project was received from John Olsen and Doug Ray.
- A large-format iMac was donated by Troy's contact, Tom Leong of i2Print. This will allow us to upgrade the network and retire 2 old computers.
- Signature Gifts slightly exceeded last year's net (1.1%)
- A County microenterprise grant is being reviewed to see if it may be a good fit for us.
