COMMITTEES:

Finance:

Marc gathered rates from all Sullivan County banks. Sterling National Bank is offering a 14 month CD at 1.85% with the condition of maintaining a checking account relationship. TD Bank is offering a 12 month CD at 1.75% with a rate bump feature. Catskill Hudson Bank (CHB) is offering a 15 month CD at 1.75%. As we already have a relationship with CHB, the board decided to transfer the \$50,000 from the money market to the CHB CD. The motion for the transfer was made by Gay, seconded by Marc.

Special Events Committee:

The committee was supposed to meet on Saturday to put together the bags but the meeting was canceled and will be rescheduled. The stickers are printed and only need to be placed on the bags. Melissa enjoys putting together the mystery bags and will continue to do so.

Recognition Event:

Tutors were surveyed and the majority did not feel an event was necessary. Other feedback included after work was much more doable than a weekend. Marc suggested sending thank you cards. DIRECTOR'S REPORT:
