We, the undersigned citizens of the United States, hereby associate to form a non-stock corporation under the provisions of Chapter 2 of Title 13.1 of the 1950 Code of Virginia and to that end set forth the following:

- A. The name of the corporation is The National Wild Turkey Federation, Inc..
- B. The purposes for which the corporation is organized are exclusively educational and charitable, and shall be to establish, maintain and promote interest in the protection and propagation of the American Wild Turkey; to raise money for developing, preserving, restoring and maintaining Wild Turkey breeding grounds; to give and promote entertainments, lectures, exhibitions, of any and all descriptions for the general instruction of the members and general public; and to do all other things necessary and proper in the furtherance of said objectives, not inconsistent with its exclusively educational and charitable objectives.

In addition, the corporation shall have the power to purchase, hold and dispose of property, real, personal and mixed, and to receive the same either by gift, grant or devise; and to make leases, deeds and contracts incident to its purposes as hereinabove stated.

- C. The corporation shall have members upon application approved by the Board of Directors.
- D. The directors of this corporation shall serve for a term of one year and shall be three in number, or such other number, not less than three, as may be established by the

- E. The post office address of the initial registered office is 1103 Princess Anne Street, Fredericksburg, Virginia, 22401. The name of the City in which the initial registered office is located is the City of Fredericksburg. The name of its registered agent is W. M. Scaife, Jr. who is a resident of Virginia, a member of the Virginia State Bar, and whose business office is identical with such registered office.
- F. The number of directors constituting the initial Board of Directors is three and the names and addresses of persons who are to serve as the initial directors are:

- G. Directors subsequent to the initial Board of Directors shall be elected by the Board of Directors.
- H. This corporation shall be a non-profit corporation, and no part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments or distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.
- I. In the event the activities of this corporation are discontinued and its holdings are liquidated, all proceeds of the same shall be distributed to an organization exempt under Section 501 (c)(3) of the United States Internal Revenue Code
