# 2. Committees Restructuring and Updates (In Compliance with the Bylaws):

### 3. Contracts and other opportunities

- NY Prize: Carol and Stephen have initiated outreach to the Village of Liberty and Village of
  Monticello to develop micro-grid projects, and have been approached by Booz Allen Hamilton to
  develop the proposals. Booz Allen will provide an informational presentation to officials of the
  two villages.
- CCA: Mike Gordon of Joule Assets has offered his assistance to help us develop a CCA proposal for Sullivan County. Bruce Ferguson and Dick Riseling have reached out to Sustainable Westchester and to Jen Metzger in Ulster County for advice on how to proceed.

- Climate Smart Communities: Work continues with the Bethel and Lumberland committees.
   VHB Engineering will provide two roundtables for program participants, focusing on LED street lighting and solutions to GHG emissions from wastewater treatment and septic systems. Carol Roig and Stephen Stuart are scheduled to perform a site visit and provide energy advice to thee Hortonville Fire Department on March 19<sup>th</sup>.
- Outreach to Montreign/Adelaar: Bruce Ferguson proposed that the Board should draft a letter introducing SASD and offering assistance with sustainable design and energy strategies.
