## **BIG GAME REPORT 9-9-15**

SULLIVAN COUNTY LEGISLATURE

- 1. Even though no changes were to be made until 2016, the DEC adopted a rule to redirect hunter effort toward antierless deer by making the first 15 days of the early bowhunting season and all of the late bowhunting and late muzzleloader season in WMUs 1C, 3M, 3S, 4J, 8A, 8C, 8F, 8G, 8H, 8N, 9A, and 9F valid only for antierless deer.
- 2. New York State has the most stringent youth hunting regulations in the nation. Assemblywoman Aileen Gunther introduced A8358 and Senator Joseph Griffo introduced the Senate version S5434 that would remove unnecessary restrictions on the types of weapons that those over 12 years of age may use and the type of game they may pursue. This bill won't advance without the support of the sporting community because strong opposition is expected from New York City legislators.

## NRA REPORT 9-9-15

- 1. A New York state supreme court judge told Gov. Andrew Cuomo he has 30 days to appeal or turn over documents related to a gun-rights rally last year during which state troopers allegedly intimidated attendees and violated their First Amendment rights. SCOPE which stands for Shooters Committee On Political Education contended Cuomo and his staff enacted rules and regulations for state police enforcement so the April 2014 rally in front of the state capitol would be disrupted. SCOPE sued to obtain documents related to the rally after the state refused to turn them over following a Freedom of Information Law request, citing attorney-client privilege.
- 2. The New York State Rifle and Pistol Association is endorsing Judge Norm Massry for State Supreme Court in the Third Judicial district which includes Sullivan County. The NYSRPA has stated that Judge Massry has demonstrated that he is a protector of our Constitution and Bill of Rights.
- 3. Obama. Biden, Bloomberg and the rest of the antigun cohorts are pushing for a federal license to purchase a handgun in the wake of the Charleston shootings which will create a federal registration of gun owners. Under current law the NICS check should have denied the Charleston shooter the ability to purchase a firearm but the government was too slow in updating their records. New laws will enable the government to confiscate firearms as was done in Australia which Obama is always touting and will not prevent crime as the antigunners falsely promise.
