Letter received from Jeremy Hurst, Big Game Unit Leader, DEC, indicating we should improve habitat quality on the lands our clubs manage by harvesting trees and increasing the amount of young forests, planting trees and shrubs and maintaining forest openings with native forbs. This will result in increased deer weight, increased antler development and higher productivity among young fawn and yearling dose and greater overwinter survival. We received two letters from Sen. Bonacic, one indicating he will support the bills for lowering the age for universal hunting licenses from I4 years old to I2 and also relating to crossbows. He also indicated the DEC is accepting public comments on proposals for hunting black bears and white tail deer and for fisher and general trapping regulations. Comments on bear and deer must be received by June 25 and trapping by June 10.

## NRA REPORT 6-8-16

- 1. Donald Trump received the official endorsement for President of the Office United States by the National Rifle Association at their Annual Meeting in Louisville, KY on May 20, 2016.
- 2. With Democrat Todd Kaminsky winning the seat of former Republican majority leader Dean Skelos in a special election, the NYS Senate majority could end up being shifted towards the Democrats. Republican Chris McGrath lost the seat by less than 1,000 votes and a court challenge is possible that would delay any possible power swing to the Democrats before the legislature adjourns. If the Democrats take control of the NYS Senate in the upcoming November elections, Cuomo and the downstate Democrats will be able to pass every gun and ammunition restriction they desire.
- 3. It is imperative that the Republicans retain control of the US Senate in the upcoming November elections otherwise New York Senator Charles Schumer will be in line to take control of the Senate. Wayne LaPierre executive vice president of the NRA stated that "When it comes to the Second Amendment Schumer is possibly the most rabidly aggressive ruthless and spiteful enemy of the right to keep and bear arms ever to serve in congress." Schumer also wants to pass legislation that will give congress the power to regulate the First Amendment by creating endless fine print alterations that would destroy the guarantee of free assembly and free speech. Schumer's version of the First amendment would begin the process of banning grassroots communication expenditures for political speech. Schumer labeled the NRA's use of contributions to get their message out to voters "the poisoning of our political dialogue" and he would outlaw the NRA's ability to do so. For political convenience Schumer, like Hillary Clinton glibly claim to embrace the Second Amendment, but always with escalating infringements on the right to keep and bear arms.
- 4. Hillary Clinton was interviewed by George Stephanopoulos on Sunday June 5<sup>th</sup> and when questioned about an individual right to keep and bear arms Hillary responded that for most of our history until the decision of the late Justice Scalia, localities, states and the Federal government had a right as we do with every amendment to impose reasonable regulations. Hillary also stated that she was for comprehensive background checks, closing the gun show loophole, closing the online loophole, and closing the Charleston loophole and passing a law that would make manufactures and sellers of firearms liable for any misuse of a firearm. Hillary also didn't rule out a tax on firearms and ammunition and referred to the San Bernardino terrorist attack as the San Bernardino gun violence.
- 5. On June 28<sup>th</sup> there will be a Republican and Democrat primary in the 19<sup>th</sup> Congressional District. Republican John Faso is the only candidate running that has received an "A" rating from the NRA.

## **BIG GAME REPORT 6-8-16**

- 1. The legislation to lower the minimum big game hunting age to 12 sponsored by Assemblywoman Gunther and Senator Gritto will likely not see any movement until the end of the current legislative session.
- 2. The DEC has temporarily halted a regulatory proposal to ban deer urine until further review involving the Department of Agriculture and Markets.
- 3. A regulatory package announced by the DEC includes a proposal to expand the state's youth deer hunt to include black bears as well. This will allow 14 and 15 year olds to harvest a bear as well as a deer during the 3 day hunt.
- 4. A group called the NYS Whitetail Management Coalition has criticized the DEC's decision to encourage voluntary restraint on harvesting yearling bucks and continues to push for mandatory antler restrictions across the state.
